Uses of funds during the year

**Summary:** This is a status report of unobligated funds which are available for use by the Board of Supervisors in the current fiscal year. These funds are not part of the Operations & Maintenance Budget.

Reflected on the report is the mandatory reserve, the amounts spent this year (FY 17 Supplemental Appropriations and use of committed or assigned funds), as well as amounts assigned to meet upcoming obligations in the current fiscal year. Committed funds are accumulated across fiscal years for the stated purpose.

This report reflects funding for all FY 2018 Supplemental Projects and all 5 years of the FY 2018-2023 Capital Improvement Plan. This report also reflects the newly created committed fund for code enforcement, as well as \$ 254,406 set aside for parks within the assigned funds and the Fines & Forfeiture committed fund.

Funds available for use are \$2,162,067as of September 30, 2017.
