A RESOLUTION, NO. 2018-0001-R

A resolution, designating Learning Lane and the Madison Heights Elementary School Access Road as State Route 9020.

Approved as to form by the County Attorney

BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST, VIRGINIA:

I. That the Board of Supervisors of Amherst County hereby designates Learning Lane and the Madison Heights Elementary School Access Road as State Route 9020, and hereby requests that the Virginia Department of Transportation (“Department”) take certain school bus roads into the secondary system of state highways, as follows:

WHEREAS, the roadway sketch attached hereto as Exhibit A, and the roads described on the Department’s Additions Form-4.3 (hereafter, “Streets”) attached hereto as Exhibit B, both of which are fully incorporated herein as part of this Resolution defines access for school bus traffic from State Route F-622 (River James Drive) to the Madison Heights Elementary School, a public school,

WHEREAS, the Area Land Use Engineer for the Department has advised the Board of Supervisors that construction of the roads is complete and meets standards, deemed by the Department of Transportation, appropriate for the traffic anticipated,

WHEREAS, construction of the roads was financed by sources other than those administered by the Virginia Department of Transportation,

WHEREAS, the Amherst County School Board and this Board hereby guarantees a minimum right of way of 30 feet and additional drainage and slope easements as necessary for maintenance of the road,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST, VIRGINIA:

That, pursuant to §33.2-325 Code of Virginia, requests that the Department add the streets identified on the incorporated Form AM-4.3 to the secondary system of state highways,

BE IT FURTHER RESOLVED:

That a copy of this Resolution 2018-0001-R certified by the office of the Amherst County Attorney be supplied to the Clerk for transmittal to the Department's Area Land Use Engineer.

II. That this resolution shall be in force and effect upon adoption.




