4. DRAFT OF PROPOSED ZONING AMENDMENTS

A. Breweries

Mr. Mitchell read the draft definition of a Brewery that staff had written:

Brewery. A facility for the production and packaging of malt beverages of low alcoholic content for distribution, retail, or wholesale, on or off premise. The development may include other uses such as a restaurant as otherwise allowed in the zoning district.

Breweries will be a special exception use in the A-1 Agricultural, V-1 Village District and as permitted in the B-2 General Commercial District and the M-1 Industrial District.

Motion to remove the word "malt" from the Brewery Definition and submit the draft to the County Attorney to be put into the form of an ordinance and returned for the Planning Commission to review.

5. <u>DISCUSSION OF DISCRETIONARY ASPECTS OF THE ZONING ORDINANCE</u>

Mr. Bryant briefly explained that the County Attorney questioned whether the County should be exempt from certain aspects of the zoning ordinance (examples: building permits, zoning permits, fee's, signs, public hearings, etc.). Mr. Bryant stated that he felt if citizens and business owners were required to pay certain fees and guidelines then the County should be accountable as well.

The Planning Commission agreed.

The Planning Commission came to a consensus that this would be further discussed at the next meeting.

6. MONTHLY REPORT FOR DECEMBER 2013

Mr. Bryant commented that December months are usually slower. Mr. Bryant also stated that single family dwellings for that year have increased from previous years.
