The Board need not adhere to the requirement for district representation if qualified persons do not apply. Directors shall retain their seats until their successors are appointed. Adoption of the ordinance shall not operate to terminate the membership of any person serving as a director on the Authority; instead, all appointments made subsequent to the effective date of the ordinance will be in accordance with its terms.
