#### D. Public Safety

1. FY2014 -2015 Volunteer Capital Funding Request

Gary Roakes, Director Public Safety/Fire Marshal, advised the Board the Monelison Volunteer Fire & Rescue Squad spent \$15,036.01 to replace the engine in Rescue Unit 51 rather than replace the entire vehicle. They are requesting reimbursement to their capital funds of \$9830.

Supervisor Marks questioned the capital funding request and provided his reason for not agreeing with reimbursement to the Monelison Volunteer Fire & Rescue Squad for this amount.

Supervisor Marks addressed the Board and made a motion to deny the request.

Supervisor Tucker requested to continue deliberation and discussion and invited Mr. Roakes back to explain the basis for his recommendation to approve.

Supervisor Tucker admired the department being proactive, taking care of what they have and fixing equipment which does not cost the taxpayers. Supervisor Tucker stated her opinion that the money should be reimbursed back to Monelison Rescue.

Supervisor Marks said he appreciated the volunteers and believes the Board does take care of the volunteers very well; however, he was unable to approve the \$9,830 request.

#### VII. County Administrator Report

Mr. Rodgers advised the Board that several months ago he and Ms. Bowyer were invited on a river float trip given by Pat Calvert, Upper James Riverkeeper as an educational and informative way to see the state of the river and the environment. Mr. Rodgers informed that Mr. Calvert has invited the Board to take a river float trip in the spring, which will begin at Monacan Park and take approximately four hours. Mr. Rodgers solicited from the Board their availability to take a 4-hour river trip on a Thursday. The members indicated they were all available and Mr. Rodgers indicated he would follow up with the Board on the exact date the Riverkeeper could proceed.

Mr. Rodgers next addressed the Board regarding the draft O & M budget and explained the materials they had been provided for the Board's review and discussion at the next meeting.

Mr. Rodgers advised the Board he has been appointed to VACO's Environment and Agricultural Steering Committee which meets a couple times a year.

Supervisor Tucker invited Mr. Roakes to come forward to answer questions that the Board may have regarding these documents and the incentive plan's success.

Mr. Roakes stated that the incentive plan has helped, as well as running the Fire Academy. Mr. Roakes said the fire departments have increased membership and he believes the class has helped more than the incentive plan.

Chairman Pugh stated the Fire Academy helps to provide training to do the job. Mr. Roakes agreed and also reported EMS calls are up as more people are going to the emergency room instead of going to doctors.

Supervisor Marks asked a question regarding the number of volunteers that met the criteria of active member (he was told approximately 60) and based on that preliminary information, what needs to be done to verify that.

Mr. Roakes informed that all the data from the volunteer fire departments had not been submitted before the Board's agenda was due; however, the numbers received have fallen in line regarding what they qualify for and are right on track as far as 60 individuals receiving an incentive this year.

Supervisor Marks stated it seemed last year took longer and Mr. Roakes informed that all paperwork is in place. Mr. Roakes stated in February he will audit some of the information of each organization and make sure it is accurate. He will then proceed with the process to pay the incentive as well as disburse the 1099s for those members who received all the benefits over \$600.

Mr. Roakes further stated once he receives all the information of who qualifies for the full incentive this year as in the previous year, he will provide that data to the Board.

Chairman Pugh asked Mr. Roakes if there has been any recent discussion about incentives in the Emergency Services Council meeting from the fire chiefs who sit on that Board. Mr. Roakes advised they talked about this in the October 2014 meeting as well as the criteria of an active member, what each person receives, probationary and active members, and to clarify what each member needs to do to qualify to receive the incentive plan. The third tier is the incentive plan that includes everything an active member has to do as well as following the rules and regulations of each department.

Mr. Roakes believes the departments have done a good job in upholding the integrity of the program.

## C. Resolution 2015-0003-R to provide for the establishment of various petty cash funds held or overseen by County Constitutional Officers.

Ms. Bowyer explained to the Board that Resolution 2015-0003-R is basically an accounting housekeeping measure. The auditors have identified some issues with petty cash and this resolution will bring the County current with state law. Ms. Bowyer advised she will supply a copy of the resolution to the auditors if approved by the Board. (See Attachment 2)

#### B. Discussion regarding AMERESCO

Chairman Pugh raised several issues regarding reconsideration of the January 20, 2015, motion including the time it will take to get the equipment, and if the Board does consider a different route, what are the savings with a piece of equipment that is not as efficient?

Supervisor Marks reminded the Board the chiller does not pay for itself.

Supervisor Kidd stated he thought this program was about efficiency, and talking with engineers about this chiller, he said the County will be paying top dollar since it appears this chiller will be a top of the line or "Cadillac chiller".

Supervisor Curd thanked staff for putting this together and it has been a welcome change to the budget process.

Chairman Pugh enjoyed the process and stated it has been difficult to prioritize items without knowing the funding. Mr. Rodgers suggested that the Board propose one change at a time and deal with that change. This process will break it into smaller decisions and how the Board prioritizes what needs to be done.

The discussion continued regarding issues of additional staff for departments and several staff addressed questions from the Board.

Supervisor Tucker asked if the Supplemental Budget sheet is a public document and Mr. Rodgers advised it is on the County's web site.

Chairman Pugh stated that the Fire Academy has been a success and that the Board should move the funding for the Fire Academy Training (item 3) up above the replacement of 1980 tractor (item 45).

Supervisor Marks inquired about the Action Tracker and the list of unsafe/burnt buildings. Supervisor Marks would like to have a date put in and what is to be accomplished on this particular date. He stated this would be a great management tool for the Supervisors to use and would like to recommend this be done in the future.

Amherst County Board of Supervisors County Ordinance No. 2015-0002

#### **AN ORDINANCE, NO. 2015-0002**

Amending §§ 15-36, 15-38, 15-39, and 15-41 of, and adding § 15-44 to, Division 2 of Article II of Chapter 15 of the Amherst County Code, to modify and strengthen provisions governing cross-connections and backflow:

FIRST READING: February 3, 2015 PUBLIC HEARING: February 17, 2015

#### THE COUNTY OF AMHERST HEREBY ORDAINS:

§ 1. That sections 15-36, 15-38, 15-39, and 15-41 of Division 2 of Article II of Chapter 15 of the Amherst County Code be and hereby are amended, as follows:

Sec. 15-36. - Definitions.

The following words, terms and phrases, when used in this division, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

Air gap separation means the unobstructed vertical distance through the free atmosphere between the lowest opening from any pipe or faucet supplying pure water to a tank, plumbing fixture, or other device and the rim of the receptacle.

Auxiliary water system means any water system on or available to the premises other than the waterworks. These auxiliary waters may include water from another purveyor's waterworks; or water from a source such as wells, lakes, or streams; or process fluids; or used water. They may be polluted or contaminated or objectionable, or constitute a water source or system over which the water purveyor does not have control.

Backflow means the flow of contaminants, pollutants, process fluids, used water, untreated waters, chemicals, gases, nonpotable waters into any part of a waterworks.

Backflow prevention device means approved device, method, or type of construction intended to prevent backflow into a waterworks.

Consumer means the owner or person in control of any premises supplied by or in any manner to a waterworks.

Consumer's water system means any water system located on the consumer's premises, supplied by or in any manner connected to a waterworks.

Contamination means any introduction into pure water of objectionable or hazardous materials or microorganisms, wastes, wastewater, undesirable chemicals or gases.

Cross-connection means any connection or structural arrangement, direct or indirect, to the waterworks whereby backflow can occur.

Degree of hazard is derived from an evaluation of the potential risk to health and the adverse effect upon the waterworks.

Double gate-double check valve assembly means an approved assembly composed of two (2) single, independently acting check valves including tightly closing shutoff valves located at each end of the assembly and petcocks and test gauges for testing the watertightness of each check valve.

Health hazard means any condition, device, or practice in a waterworks or its operation that creates, or may create, a danger to the health and well-being of the water consumer.

Interchangeable connection means an arrangement or device that will allow alternate but not simultaneous use of two (2) sources of water.

*Pollution* means the presence of any foreign substance (chemical, physical, radiological, or biological) in water that tends to degrade its quality so as to constitute an unnecessary risk or impair the usefulness of the water.

Pollution hazard means a condition through which an aesthetically objectionable or degrading material may enter the waterworks or a consumer's water system.

*Process fluids* means any fluid or solution which may be chemically, biologically or otherwise contaminated or polluted which would constitute a health, pollutional or system hazard if introduced into the waterworks. This includes, but is not limited to:

- (1) Polluted or contaminated waters;
- (2) Process waters:
- (3) Used waters originating from the waterworks which may have deteriorated in sanitary quality;
- (4) Cooling waters;
- (5) Contaminated natural waters taken from wells, lakes, streams, or irrigation systems;
- (6) Chemicals in solution or suspension; and
- (7) Oils, gases, acids, alkalis and other liquid and gaseous fluids used in industrial or other processes, or for fire-fighting purposes.

Pure water or potable water means water fit for human consumption and use which is sanitary and normally free of minerals, organic substances and toxic agents in excess of reasonable amounts for domestic usage in the area served and normally adequate in supply for the minimum health requirement of the persons served.

Reduced pressure principle backflow prevention device means a device containing a minimum to two of two (2) independently acting check valves together with an automatically operated pressure differential relief valve located between the two (2) check valves. During normal flow and at the cessation of normal flow, the pressure between these two (2) checks shall be less than the supply pressure. In case of leakage of either check valve, the differential relief valve, by discharging to the atmosphere, shall operate to maintain the pressure between the check valves at less than the supply pressure. The unit must include tightly closing shut-off valves located at each end of the device, and each device shall be fitted with properly located test cocks. These devices must be of the approved type.

Service connection means the terminal end of a service line from the waterworks. If a meter is installed at the end of the service, then the service connection means the downstream end of the meter.

System hazard means a condition posing an actual, or threat of, damage to the physical properties of the waterworks or a consumer's water system.

*Used water* means any water supplied by a water purveyor from waterworks to a consumer's water system after it has passed through the service connection.

Water purveyor means an individual, group of individuals, partnership, firm, association, institution, corporation, municipal corporation, county, or authority which supplies water to any person within this state from or by means of any waterworks.

Waterworks means all structures and appliances used in connection with the collection, storage, purification and treatment of water for drinking or domestic use and the distribution thereof to the public or residential consumers as set forth in <u>Title 32.1</u>, <u>Article 2 of the Code of Virginia (1950)</u>, as amended, § 32.1-167 et seq.

#### Sec. 15-38. - Status of article.

This article is a supplement to the applicable plumbing codes <u>contained in the Uniform Statewide Building Code</u>, as that is amended from time to time, which has been adopted in its entirety by Amherst <u>County</u>.

#### Sec. 15-39. - Adoption of regulation.

The county board of supervisors Amherst County Board of Supervisors hereby adopts by reference Section 6.00 Article 4, Cross-Connection and Backflow Prevention Control in Waterworks, Commonwealth of Virginia Waterworks Regulations.

## Sec. 15-41. - County's right of entry for inspection.

The representative of the authority board Amherst County Service Authority Board shall have the right to enter at any reasonable time properties served by a connection to the waterworks of the county for the purpose of inspecting the piping system or systems for cross-connections. Upon request, the owner or occupants of property served shall furnish to the inspection agency pertinent information regarding the

piping system or systems on such property. The refusal of such information or refusal of access, when requested, shall be deemed evidence of the presence of eross-connections a high degree of hazard from cross-connection.

§ 2. That § 15-44, Violations, be and hereby is added to Division 2 of Article II of Chapter 15 of the Amherst County Code, as follows:

#### Sec. 15-44. - Violations.

- (a) The director of utilities, or his/her designee, shall send a notice of violation by certified mail to the owner of any building or structure that is found to be in violation of this article. The director, or his/her designee, shall establish a reasonable deadline in the notice of violation for the owner to correct the violation. If the owner fails to correct the violation before the expiration of the time given by the director, or his/her designee, the director, or his/her designee may terminate water service to the building or deny water service to the building.
- (b) If a backflow prevention device is removed or bypassed, if a cross-connection exists or if the pressure in the water system is lowered below ten psi gauge, the director, or his/her designee, shall take whatever actions he finds necessary to ensure that the water system is safe from pollution.
  - § 3. That this ordinance shall be in force and effect upon adoption.

A resolution, to direct the County Administrator to communicate with the Virginia State Board of Health, and its Health Commissioner, regarding the condition and status of hotels in Amherst County.

Approved as to form by the County Attorney

BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST, VIRGINIA:

I. That the Amherst County Board of Supervisors hereby directs its County Administrator to communicate with the Virginia State Board of Health, and its Health Commissioner, regarding the condition and status of hotels in Amherst County, as follows:

WHEREAS, Chapter 35.1 of the Code of Virginia establishes requirements governing the operation of hotels, restaurants, summer camps, and campgrounds, including requirements for licensure, and vests the State Board of Health ("Board") and State Health Commissioner ("Commissioner") with authority for promulgation of regulations and enforcement of State law; and

WHEREAS, counties are precluded by Virginia Code Section 35.1-9 from regulating the operation of hotels, restaurants, summer camps, and campgrounds except in the very limited areas of food, aquatic facilities, the keeping of guest registers, and display of signs, although counties retain all the powers granted them under State law, including the ability to ensure compliance with the Virginia Statewide Building Code and fire codes, and to issue and withdraw business licenses; and

WHEREAS, hotels in Amherst County have been the site of two murders and a suicide in 2014, have harbored drug activity including operation of a "laboratory" for the manufacture of methamphetamine, and appear to be permitting long-term occupancy inconsistent with the State Code definition of hotel as a purveyor of "transitory" sleeping or lodging accommodations; and

WHEREAS, the County has used some of the authority granted to it under State law to attempt to improve the quality of the hotels, but has observed no continuous improvement; and

WHEREAS, the County therefore has concluded that it must ensure that the Board and Commissioner are fully aware of the issues with the hotels so that they can use their enforcement powers to determine whether the hotels are in violation of any State laws or regulations, and take appropriate remedial action against any violations they may identify.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST, VIRGINIA:

That the Amherst County Board of Supervisors hereby directs its County Administrator to communicate with the State Board of Health and its Health Commissioner to request that they undertake inspections of all County hotels pursuant to Virginia Code Section 35.1-5 to determine whether those facilities are violating any provision of Title 35.1, any Board regulation, any order of the Board or Commissioner, or any condition in a license the Board or Commissioner has issued pursuant to Title 35.1, and to undertake any remedial action necessary.
