Chairman Kidd called the meeting to order. Supervisor Marks gave the Invocation and led the Pledge of Allegiance.

## III. Approval of Agenda

Chairman Kidd moved to amend the agenda by adding a closed session, § 2.2-3711(A) (29) of the Code of Virginia, to discuss the award of a public contract involving the expenditure of public funds, specifically the review of two PPEA proposals for the Amherst County Fire &Rescue building project, where discussion in an open session would adversely affect the County's bargaining position or negotiating strategy.

## IV. Citizen Comments

Chairman Kidd asked if anyone wished to speak, and if so, to please come forward.

Chairman Kidd asked Ms. Rice to identify necessary changes to the November 4, 2014 minutes. Chairman Kidd asked Jeremy Bryant, Director of Planning and Zoning if the property owners supported the nomination and Mr. Bryant responded in the affirmative.

## VI. New Business

## A. Planning/Zoning - Request by Ashley C. Johnson to purchase County property

Jeremy Bryant, Director of Planning and Zoning presented a report to the Board asking that the Board consider disposition of surplus real property identified as an unused right-of-way within tax map number 160A3. Mr. Bryant advised Ashley C. Johnson owns tax map parcel number 160A3-A-72 that borders the right-of-way, and wishes to purchase it for use as drain fields for her primary residence, as her existing drain fields have failed and connection to the Service Authority's system is cost prohibitive.

Mr. Bryant further advised the Board this matter will come back to board for consideration of sale and a public hearing.

## B. CDBG Water and Sewer System, Stumps Hill, Quit Claim Deed

Chairman Kidd advised the Board that a portion of the CDBG Water and Sewer System, Stumps Hill, Quit Claim Deed was addressed at the December 2, 2014 meeting of Amherst County Service Authority. Chairman Kidd advised the issue now before the Board is to authorize transfer of ownership of the above-described utilities to the Service Authority by a resolution.

On motion by Supervisor Curd, and with the following vote, the Board adopted Resolution 2014-0034-R, approving the transfer of any ownership interest held by Amherst County in the water and sewer utilities system in the Stumps Hill Area of the Old Town Madison Heights Community to the Amherst County Service Authority.

C. Engineering Analysis for Goodwin Building

Mr. Proffitt provided information to the Board regarding AMERESCO's audit of energy improvements to County buildings. Mr. Proffitt advised the Board that Engineered Systems, LLC will provide an analysis for the Goodwin Building to evaluate the HVAC system and prepare a cost estimate to construct recommended improvements for the building.

On motion by Chairman Kidd, and with the following vote, the Board voted to accept the proposal for Engineered Systems, LLC and to appropriate up to \$12,000 from the County's unobligated general fund to cover those costs.

#### D. Financial Consulting Services

Mr. David Proffitt, Deputy County Administrator/Purchasing Agent presented information to the Board regarding a proposed contract with Davenport & Company LLC to provide financial advisory services regarding the AMERESCO proposal. Mr. Proffitt advised the Board the County Attorney has reviewed the proposed contract and has recommended contracting at this time only for planning services at a cost of \$15,000.

Supervisor Marks presented a question regarding the cost of \$15,000 and Mr. Rodgers explained to the Board the \$15,000 will just cover Phase 1 (planning services).

Chairman Kidd advised he would like a financial advisor to come in to talk to the Board before moving forward.

Supervisor Pugh stated the Board had prior material prepared by Davenport & Company dated November 16, 2012 and most of the information was already in their book. Mr. Rodgers advised that since Davenport & Company has most of this information, they are ready to move forward by December 16<sup>th</sup>.

Supervisor Tucker was concerned about paying consultants \$15,000 to provide the Board with information that the Board may use or not.

Chairman Kidd advised AMERESCO is pushing for a decision on December 16<sup>th</sup> and it would make good business sense to have a financial advisor on board before obligating the County.

Supervisor Tucker stated the Board was given information by AMERESCO but did not make any decisions. Supervisor Tucker noted costs continue to go up; however, the Board will make the final decision and this can be taken in small sections making it more affordable. Supervisor Tucker further stated she cannot support paying \$15,000 to another consultant.

Supervisor Pugh voiced his concern regarding the contract stipulations. Supervisor Pugh stated the County will have to take the bond or loan out but the savings will pay for the loan. Supervisor Pugh was not clear on the guidelines as to when the loan will be paid back.

Mr. Rodgers advised that the meeting on December 16<sup>th</sup> is to have the Board's questions answered. Mr. Rodgers advised payments do not begin until six months after the construction is complete and the payments are increased as the savings arrive.

Ms. Bowyer stated the contract is dense and she can do an analysis of the contract that may put the Board in a better position to decide how to move forward.

Chairman Kidd remarked this will help and it makes good business sense to have a financial advisor come in to advise what we can do at our own pace.

Supervisor Curd stated that the Board needs to make a decision on AMERESCO and have the financial information to support this. Supervisor Curd stated he was not in favor to spend money for these consultants.

Supervisor Marks stated there are some instances money has to be put upfront especially if we hire a financial advisor.

The Board continued their discussion regarding several options and Mr. Rodgers addressed several questions presented by the Board.

On motion by Supervisor Marks, and with the following vote, the Board voted to authorize staff to execute the proposed Davenport & Company contract, dated November 25, 2014 for Financial Advisory Services, subject to the County Attorney's review and up to \$15,000 from the County's unobligated general fund be appropriated to cover the cost that this involves the planning phase.

## VIII. County Administrator Report

## A. Offer in Compromise, Pickett's Charge, LLC.

Mr. Rodgers stated the Board is being offered \$8,000 to release a lien on equipment owed by Antique Building Inc. totaling \$31,424.45.

Lee Cobb of the Economic Development Authority came forward and advised the Board the EDA recommended approval this offer and advised the Board of the possibility of a new company coming to this site and employment of ten people.

Ms. Bowyer noted for the record that the copy of the letter from the Treasurer in the Board's packet is not the correct copy. Ms. Bowyer stated the Board has been supplied a correct copy as a handout and that copies had been provided to the public. Ms. Bowyer advised the Treasurer is not making a recommendation in his letter to the Board; however, the Treasurer does believe a settlement is in the best interests of the County.

Mr. Rodgers advised one concern would be that VDOT could request billboards on the route be removed. VDOT advised it is not their practice to have existing billboards removed but to grandfather in the existing signs.

Mr. Bill Gillespie of MRG Consulting was hired to look various space needs. Staff proposed the following to address the space needs issue without requiring additional funds:

Administration Building - add 10,000 sq.ft. extension to north end of the building

Monroe School - move Recreation & Parks to Monroe School

Former Amherst Baptist Church -lease building to nonprofit organization

Parsonage - use for storage

Goodwin Street - replace HVAC

Monelison Fire & Rescue - extend Rescue Squad Building to provide living quarters.

There was a Board discussion and questions presented to Mr. Gillespie.
