Richie stated that the ESC formed a committee for recruitment and retention. They explained the incentive process and answered Board questions. The Chiefs and the Captains check that criteria has been met for incentives, and it is reviewed by the Public Safety Director, Mr. G. Roakes. ESC can break information down concerning active members and bring it to the Board. Mr. Roakes believes the incentive program needs to stay the same. Ms. C. Tucker wanted to take the opportunity to thank the ESC for raising the numbers of the Amherst Fire Department. She has heard from the parents of Junior Members are pleased with the experience the young people are getting. Mr. D. Pugh also thanked Mr. Richie.

Mr. J. Marks brought up the capital expenditures that were discussed at a previous meeting. He stated he would make a motion then speak of the motion.

Mr. J. Marks motion is that the money designated for capital expenditures in the Emergency Services Council budget for fiscal year 2014-2015, and future years, be retained by the Board of Supervisors and dispersed based on appropriation requests from the Emergency Service Council and the Director of Public Safety to the Board of Supervisors. Any funds remaining at the end of

2014-2015 fiscal year, and future years shall be carried over to the following fiscal year. This money is designated for use for emergency services and shall not be used for any other purpose.

Mr. J. Marks spoke on his motion and gave several reasons why he felt the need to make this motion. VA Fire service board supports this type of action. Currently 2 of 31 vehicles are titled or co titled to the County. No way will this impact the amount of money for capital expenditure for emergency services. Treat Emergency Services as other County agencies are treated. Article of incorporation – any dissolution of department, the assets do not necessarily come back to the citizens of Amherst County.
