Chairman Pugh called the meeting to order at 1:01 p.m.

Citizen Comments IV.

Chairman Pugh opened the Citizen Comments section.

The following citizens spoke in opposition to Ordinance 2015-0014: Ruth Martin; Terrick Moyer, Madison Heights, VA; Finis Southworth, Lynchburg, VA; Leon Parrish, Madison Heights, VA; Thomas Wright, Forest, VA; Alan Wood, Madison Heights, VA; Bill Peters, Amherst, VA.

The following citizens spoke in opposition to the Wireless Communications Facility at Elon Elementary School: Florence Foster Nixon, Madison Heights, VA; Holcomb R. Nixon, Madison Heights, VA; Jim Thompson, Madison Heights, VA; Abby Thompson, Madison Heights, VA;

Mr. Alan Wood, Madison Heights, VA addressed the Board and thanked the Board for the progress that has made regarding the school building project.

Mr. Wood also commented on the proposed cell tower at Elon Elementary and advised that the School Board considered everything, that it was a tough decision but made in the context of what the School Board understood. Mr. Wood stated the School Board did its job and he is comfortable with the decision made.

Mr. Bill Peters, Amherst, VA addressed the Board with several comments regarding Ordinance 2014-0014 and questioned paragraph 2 in the ordinance. Mr. Peters stated this revision today fixes what is wrong and asked the Board to pass the ordinance today. Mr. Peters stated this ordinance will fix the terrible reputation the County has regarding hotels and motels and pleaded with the Board that it ensure that the Commissioner of the Revenue will receive funding and staff to implement this.

Chairman Pugh closed the Citizen Comment section.

V. Ordinance - First Read

A. Ordinance 2015-0014, amending §§ 14-141, 14-144, and 14-151 of the Amherst County Code to remove the status as a convicted felon, the inability to demonstrate financial responsibility, the inability to physically carry on the business, having been adjudicated as incapacitated, and a prior history of having been intoxicated or under the influence of some self-administered drug while upon the licensed premises as a basis for revocation or denial of a business license; to eliminate the reference to the grant of a business license as a privilege; and to make additional technical changes.

Ellen Bowyer, County Attorney, presented to the Board and stated that the Board had adopted changes to the business license requirements in April 2015.

Ms. Bowyer stated that the ordinance presented today amends County Code to remove the status as a convicted felon, the inability to demonstrate financial responsibility, the inability to physically carry on the business, having been adjudicated as incapacitated, and a prior history of having been intoxicated or under the influence of some self-administered drug while upon the licensed premises as a reason for revocation or denial of a business license; if eliminates the reference to the grant of a business license as a privilege; and it makes additional technical changes.

Ms. Bowyer stated the ordinance is before the Board on a first read and the recommendation is to send this ordinance to a public hearing.

Chairman Pugh explained the Board made an error, now corrected and agreed with all of the citizens' comments made earlier at this meeting.

Vice-Chair Tucker commented that a mistake was made and the Board is here to correct this mistake. Vice-Chair Tucker thanked all who contacted her and said this is how democracy is supposed to work.

The Board discussed several issues regarding the reference to public property and the process of revocation of a business license. The Board amended Ordinance 2015-0014 page 4 of Sec. 14-151, 5) as follows, "Has failed to take reasonable measures to prevent: (i) the licensed premises or (ii) any premises immediately adjacent to the licensed premises that are owned or leased by the licensee; or (iii) any portion of public property immediately adjacent to the licensed

premises from becoming a place where patrons of the establishment commit criminal violations, and such violations lead to arrests that are so frequent and serious as to reasonably be deemed a continuing threat to the public safety"; and directed staff to proceed to public hearing on December 15, 2015.

By motion Chairman Pugh and with the following vote, the Board amended Ordinance 2015-0014 and directed staff to proceed to public hearing on December 15, 2015.

VII. New Business

A. Planning/Zoning – Virginia Code 15.2-2232 Review – Wireless Communications Facility – Elon Elementary School

Jeremy Bryant, Director of Planning/Zoning presented his report to the Board. Mr. Bryant stated that on November 9, 2015, Milestone Communications Management III, Inc. submitted a site plan for the construction of a wireless communications facility at Elon Elementary School. A contract for a cell tower located at Elon Elementary school was approved by the Amherst County School Board.

The Planning Commission met on November 19, 2015 to determine if the proposed cell tower, to be located on public lands, would be in compliance with the County's Comprehensive Plan pursuant to Virginia Code §15.2-2232. The Planning Commission determined that the proposed wireless communications facility at Elon Elementary school was substantially in accord with the Plan and that a public hearing was not necessary before final approval of the proposed site plan.

Supervisor Marks questioned what factors led the Planning Commission to come to their conclusion and the reasoning for their vote. Supervisor Marks stated that the Planning Commission is now asking the Board of Supervisors to approve this; however the Planning Commission did not provide their justification.

Ms. Bowyer explained to the Board that the Planning Commission makes a decision and communicates their decision to Board of Supervisors. The Board of Supervisors can make another determination. Ms. Bowyer clarified the Board has two options; to overrule the Planning Commission's decision or require that the Planning Commission hold a public hearing.

Supervisor Marks stated he wanted to make it clear this is not a decision to build or not build a tower, but whether decision is in accord with the Comprehensive Plan.

Ms. Bowyer advised the Planning Director's approval of a specific tower can be a by-right action so long as the Planning Commission determines that the project is in substantial accord with the Comprehensive Plan.

By motion of Supervisor Marks and with the following vote, the Board directed the Planning Commission to vacate its prior determination, hold a public hearing on the question of whether the Elon cell tower project is substantially in accord with the Comprehensive Plan, and advise the Board of its determination and the specific findings supporting that determination in writing in accordance with paragraph B of Virginia Code 15.2-2232.

B. Purchasing - School Infrastructure Building Project

David Proffitt, Deputy County Administrator addressed the Board and presented his report regarding two proposals from Southern Air, Inc. and Amersco.

Mr. Proffitt advised both of these proposals have been analyzed by the School Infrastructure Building Committee. The Committee unanimously approved by motion on November 23, 2015 to enter into contract negotiations with Southern Air, Inc. for proposed school infrastructure improvements. The Committee refined the scope of work and developed a project implementation schedule.

Mr. Bill Gillespie of MRG Consultants provided the Board with an overview as to energy and environmental issues and stated the Southern Air proposal provided a better look at new technology, energy savings for the building and LED lighting and was the best proposal for the County.

The engineers have advised this would be costly; therefore, the County is now moving on a criminal track working with the Commonwealth's Attorney to file a criminal complaint against the owner this day.

Riveredge Park construction - The trail bed has been laid and ready for asphalt to be put down before the asphalt plant closes for winter.

Train Depot – Documents have been submitted to VDOT. VDOT has submitted back a request for a new cost estimate for the work. Once VDOT has all information, it will take approximately two weeks to get permission allowing the County to proceed.

Learning Lane – The County Attorney has drafted conveyance documents for signature by existing owners to convey easements to the County in order that those easements can be conveyed to VDOT.
