VI. Special Presentations

A. Derek O. Keiser, Forest Technician Specialist/Forest Warden - Virginia Department of Forestry

Mr. Derek Keiser, Forest Technician/Specialist/Forest Warden and Mr. Bill Perry, Forester for the James River area of the Virginia Department of Forestry addressed the Board and presented an overview of services the Department provides to Amherst County.

Mr. Keiser reported fire incidents in the County are low and offered assistance to volunteer fire departments. Mr. Keiser advised in a five year span there were 56 incidents with approximately 470 acres burned in the County. The Department of Forestry offers fire protection to homes, protection to approximately 177,000 acres of private land, training to volunteer fire departments at no cost, provides grants to volunteer fire departments for dry hydrants, offers assistance with a 50/50 grant for protective equipment paying up to \$5,000 and provides law enforcement of the 4PM burn law from February 15 to April 30. The Department also assists with help on structure damage, flooding, traffic control, cutting trees, water quality and logging.

Mr. Perry explained the work that he does focuses on private landowners, including field visits, recommending services and forest stewardship planning. Mr. Perry discussed cost share programs that include the Virginia seedling program for wildlife habitat as well as working with private landowners on conservation easements.

VII. Old Business

A. Discussion of Draft Regulation - ACR 1-3, Internal Boards, Committees, Commissions and Councils

Mr. Rodgers advised the purpose of this draft Regulation ACR 1-3 is to provide guidance to citizens serving on these boards and creation of charters so citizens who sit on these boards will know what is expected of them.

Mr. Rodgers recommended that the Board approve the regulation. He will then bring the charters back to the Board one at a time. In addition to those boards, the Building Appeals Board, Board of Assessors and Board of Equalization will be included.
