I. Call to Order

Chairman Marks called the meeting to order at 1:00 p.m.

II. Invocation and Pledge of Allegiance

Chairman Marks led the Invocation and Pledge of Allegiance.

Chairman Marks welcomed all in attendance.

III. Approval of Agenda

IV. Citizen Comment

Chairman Marks opened the Citizen Comment session.

The following citizens came forth to address the Board:

Ms. Bonnie Dawson; Mr. Ed Dawson; Mr. George Mann; Ms. Jean Burley Mann; Mr. Billy Jennings; and Ms. Sadie Jennings.

Ms. Sadie Jennings addressed the Board and requested the Route 743 Lavender Lane be surface treated. Ms. Jennings stated the road is bad condition and needs a guardrail installed in the sharp curve where water runs across the road.

Vice-Chair Pugh asked Mr. Don Austin, VDOT Residency Administrator (in the audience) if this road could be placed on the Rural Rustic Priority list in the Six Year Plan.

Mr. Austin said this road could potentially be added to the Rural Rustic Priority List if there was sufficient traffic and it qualified for funding.

Chairman Marks advised a Public hearing is set for May 17, 2016 at 7:00 p.m. for the VDOT Secondary System Construction Six Year Plan Rural Rustic Priority List. Chairman Marks recommended those citizens to attend.

Chairman Marks closed the citizen comment session.

Mr. Don Austin, VDOT Residency Administrator, addressed the Board regarding the Six Year Plan. At the last meeting there were 14 roads on the Rural Rustic List, however, he received word last week of an allocation and now can add Wares Gap Road and Lavender Road to this list. Mr. Austin explained the Rural Rustic List is used to develop a plan for the next six years.

Board members discussed several other roads; Campbell's Mill Road, West/East Perch Road, Beck Creek Road, Ashby Wood Road and Ramsey Road. Mr. Austin advised he can make adjustments to the list before the May 17th hearing if any of those roads qualified.

Mr. Austin advised the Board that HB2 funding for Amherst County, based on the recommendation by the Commonwealth's Transportation Board, will fund projects in Madison Height's, the Town of Amherst and Woody's Lake Road.

Chairman Marks thanked Mr. Austin for this information.

Chairman Marks advised the next order of business was reconsideration of Resolutions 2016-0012-R and 2016-0011-R.

Supervisor Tucker asked why the Board was changing the resolutions and wanted confirmation that these changes and subsequent vote would not affect the outcome or the makeup of the resolutions.

Ms. Bowyer addressed the Board and said the Board adopted five resolutions at the last meeting on April 29, 2016. Resolution 2016-0012-R regarding the School Board budget was adopted as published and thought the published version incorporated some changes to the state allocation; however, it did not capture all of those allocations.

Ms. Bowyer advised the Board they are voting on the same resolutions and she will read all of those changes. Ms. Bowyer advised the Board would take the same action as the published resolution. Ms. Bowyer suggested that on future adoption of budgets by resolutions, that the Board take a 15 minute recess to confer with staff to make sure all of the necessary changes are made before the Board votes.

Vice-Chair Pugh and Chairman Marks asked for clarification on their vote on Resolution 2016-0012-R and Resolution 2016-0011-R. Mrs. Rice confirmed the Board vote on each resolution was AYES - 5/0.

Chairman Marks then stated there would be a motion to reconsider the Board's previous vote on Resolution 2016-0011-R and Resolution 2016-0012-R.

By motion of Chairman Marks and with the following vote, the Board reconsidered its action adopting Resolution 2016-0011-R and Resolution 2016-0012-R.

Ms. Bowyer stated there were three sets of amendments to Resolution 2016-0011-R and a new date for consideration for adoption:

- 1) The first amendment to page 2 under the General Fund Expenditures under the line item Fire and Rescue Services, the figure of \$2,553,739 was amended to \$2,753,739; and
- 2) The second amendment to Internal and Debt Services was changed from \$3,442,919 to \$3,242,919; and
- 3) The third amendment on page 3 was the addition of another clause; BE IT FURTHER RESOLVED that \$200,000 of the funds included in the County general operating budget be dedicated to support expenses associated with hiring three additional emergency medical services staff.

Ms. Bowyer said that if the Board decided to adopt as she explained, the motion would be to adopt Resolution 2016-0011-R as published but with the amendments described by the County Attorney today.

Mr. Rodgers said the total Non School amount was \$39,616,853 and is correct as published; and the total amount for the General Fund was \$86,506,563.

Supervisor Tucker expressed a concern about making changes that the public was not aware of what the Board was doing.

Ms. Bowyer explained the Board made all the changes that she read into the record when the Board had the public meeting on April 29, 2016. The change was made by adding the clause and was merely a technical cleanup.

Supervisor Tucker commented that this was "sloppy work" and when talking about taxpayer money the Board had an obligation to get it right the first time.

Mr. Rodgers explained this change was a surprise to the staff and had not been anticipated or prepared in advance of the meeting. Mr. Rodgers agreed with the County Attorney's suggestion for a 15 minutes recess in the future when making unplanned changes to budget resolutions.

Vice-Chair Pugh asked for clarification on his vote on Resolution 2016-0014-R and Resolution 2016-0010-R.

Mrs. Rice stated from the record of April 29, 2016, that Chairman Marks and Vice-Chair Pugh both voted NAY on Resolutions 2016-0014-R and 2016-0010-R.

B. Recreation and Parks - Riveredge Park Design Funds Request

Vice Chair Pugh was aware this item was deleted but asked about the extension of trail through Central Virginia Training Center (CVTC).

Mr. Rodgers explained there is an easement through CVTC that had a termination provision to allow CVTC to terminate that easement on a 60 day notice.

Mr. Rodgers said the County requested the Department of Behavioral Health and Human Services make that easement a permanent easement in order for the County to continue the trail.

Mr. Rodgers advised Behavioral Health declined and wanted to wait. The Amherst County Service Authority Director's was informed by the Army Corp of Engineers that they needed access to the shoreline. During a conference call with Behavioral Health and the Virginia Department of General Services, it was agreed to give the County a permanent easement.

Mr. Rodgers advised he is now waiting for General Services to finish the paperwork. This will give the County the next segment downstream to allow Riveredge Park to connect to Lynchburg on both sides of the river.

C. Public Works - Dumpster Closure at Galt's Mill - update

Mr. Rodgers explained a sign has been ordered and he is looking at the costs of other locations to see if the County wants to close additional dumpster sites.

Mr. Rodgers said there is an issue whether the County will need to modify our landfill permit to extend its weekend hours. The Public Works Director will be researching this issue with DEQ.

Chairman Marks commented that Ms. Chapman was a CPA with BrownEdwards and asked if she is being paid to sit on this committee.

Mr. Rodgers said he will find out her availability. He said that she has already reviewed the applications received and suggested three for interview. Mr. Rodgers said she is essential to be included as she understands the County's books.

Mr. Rodgers questioned what the role of this group would be and explained who he planned to assist in the interview of the applicants.

Chairman Marks asked that if we only have three applicants to interview, did we need to expand where we are looking.

Mr. Rodgers advised he has advertised on external websites, the Virginia Certified Public Finance Officer Society site, CPA sites, VACO, VML and in the newspaper.

Mr. Rodgers said he would like to include Mrs. Crouch, Ms. Chapman and Ms. Viar who all understand the processes, as the group to assist him in interviewing. Mr. Rodgers said he will add Mr. Hicks, Mr. Wood, Mr. Friend and Mr. Althouse for a total of nine people to interview

these individuals. Mr. Rodgers asked the Board for guidance on what the Board expected their role be in making a decision.

Vice-Chair Pugh said the Board may want to eliminate County staff from this panel and have no government employees. He would want someone who understands our accounting process and numbers.

Mr. Rodgers said he would like to explain to those applicants how we need to incorporate the School and Treasurer's systems and books and the internal electronic processes we use.

Chairman Marks remarked that he tended to agree with Vice-Chair Pugh and not to be concerned with understanding our system but to be concerned that this person understands what a Director of Finance does and what he is supposed to do. Chairman Marks said he did not think it urgent how the IT system and the Bright system work.

Supervisor Ayers voiced his concern having only three applicants and if it was the pay then this issue needs to be addressed.

Mr. Rodgers said we have received five applicants and the announced pay band for the position is higher than what the applicants are currently earning. Mr. Rodgers stated we can extend the announcement to keep it open longer.

Supervisor Tucker asked if those applicants are executive type people or is this job a step up for them.

Mr. Rodgers said two are step-ups; one is a CPA with a firm; one is the Chief of Accounting at Wintergreen; and the other has accounting experience.

Vice Chair Pugh said he wanted to keep the advertisement open longer.

Supervisor Tucker said we need to have a strategic thinker who has a CFO level mind set.

Chairman Marks said he would like to let this committee look at the three people who have applied. This committee may decide none of the applicants meet the requirements and recommend we broaden the search and re-advertise.

Chairman Marks asked if it was the Board's consensus that the committee determine to broaden the search and then ask the County Administrator to proceed.

A resolution, adopting and appropriating the General Fund Budget as a part of the Amherst County Budget for Fiscal Year 2016-2017.

Approved as to form by the County Attorney

BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST, VIRGINIA:

I. That the Amherst County Board of Supervisors ("Board") adopts and appropriates the fiscal year 2016-2017 County General Fund budget with expenditures in the amount of \$39,616,853.00, as follows:

WHEREAS, the County Administrator has submitted to the Board a proposed annual budget for the County for fiscal year 2016-2017 ("County Budget"), beginning July 1, 2016; and

WHEREAS, the Board has reviewed the proposed County Budget and has been apprised of the availability of revenues to support the proposed expenditures; and

WHEREAS, it is necessary to adopt the County Budget and appropriate funds to support the requirements therein; and

WHEREAS, the Board held a public hearing, properly noticed in accordance with Virginia law, on the proposed fiscal year 2017 County Budget, on April 21, 2016; and

WHEREAS, the Board now intends to adopt as part of the County Budget the fiscal year 2016-2017 General Fund budget, and appropriate the funds therein on a quarterly basis and by line for all departments except for the Department of Social Services, which funds shall be appropriated on a lump sum basis by category.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST, VIRGINIA:

That the Amherst County Board of Supervisors adopts the 2016-2017 County General Fund budget as part of the County Budget with expenditures in the amount of \$39,616,853.00, to support the following departments:

That the Amherst County Board of Supervisors ("Board") adopts and appropriates the fiscal year 2016-2017 budget for Amherst County Schools with expenditures in the amount of \$46,889,710.00, of which \$44,649,444.00, is for the regular operating budget and \$2,169,072.00 in Child Nutrition, and \$71,194.00 is for the capital budget, which expenditures are supported with \$4,367,141.00 in federal funds, \$26,308,038.00 in state funds, and \$16,214,531.00 in local funds, as follows:

WHEREAS, the County Administrator has submitted to the Amherst County Board of Supervisors a proposed annual budget for the County for fiscal year 2017 ("County Budget"), beginning July 1, 2016; and

WHEREAS, the County fiscal year 2017 budget includes funding to support Amherst County Schools ("School Budget"); and
