#### 4. PUBLIC HEARING – SPECIAL EXCEPTION

A. 2018-297 Edward Dillard, Jr.

Request by Edward Dillard, Jr. for a special exception in the A-1 Agricultural Residential District. The purpose of the special exception is to allow the breeding, raising, and training of dogs.

Ms. Bishop presented the Staff report and concluded her comments by stating that Staff recommends the following conditions:

- 1. Number of dogs: No more than 20 dogs shall be kenneled at the facility at any one time.
- 2. <u>Noise</u>: No animal shall howl, bark, whine, meow, or make other such noises which are plainly audible on the property of thirty (30) minutes or more in duration.
- 3. <u>Home Occupation</u>: Applicant shall abide by Section 905.02.3 of the home occupation ordinance, which states, "The home occupation shall not generate excessive traffic not produce obnoxious odors, glare, noise, vibration, electrical disturbance, radio activity or other conditions detrimental to the character of the surrounding area."

The Planning Commission asked a few questions pertaining to the existing entrance, the use of the property and the difference between a state kennel license and a County kennel license. Staff advised that a zoning permit for the kennel license is necessary to get a County business license permit.

Mr. Foor opened the public hearing.

Mr. Mike Bradley, resides at 1026 Sugar Hill Tunnel Rd in Amherst stated that he wasn't speaking in favor nor opposed but he did have a few questions. Mr. Bradley was concerned on the amount of dogs at any one given time, the noise, the appearance of the kennels from the road and if the applicant was in compliance with the state and county code for kennels.

The applicant responded by stating that he kept clean kennels and that the Animal Control Department comes periodically without his knowledge to inspect his kennels for cleanliness, water, food and shelter.

Mr. Thompson asked how many dogs Mr. Dillard currently had on the property. Mr. Dillard responded (22) twenty-two. Mr. Thompson responded that the day that he went out to look at the property that there were at least (35) thirty-five dogs.

Mr. Dillard responded that he temporarily boards dogs for no more than 2-5 days as well.

There being no further speakers Chairman Foor closed the public hearing.

There was no further discussion by the Commissioners regarding this case.
