Building Official Nate Young explained that the Insurance Services Office (ISO), which is an independent rating company used by insurance companies, has evaluated County Code enforcement in order to set insurance rates on structures within the County.

Mr. Young reported that the ISO issued an improved rating for Amherst County, which will tend to lower insurance rate for homeowners.

B. County Park Playground

Recreation and Parks Director Sara Lu Christian thanked the Board for approving the funding to replace aging playground equipment at Stonehouse, Thrashers Lake, and Coolwell Parks. She reported that the work has been completed on all three playgrounds.

Ms. Christian asked the Board to consider funding to replace the playground equipment at Monacan Park in the next budget cycle.

C. New Batteau at Riveredge Park

Mr. Rob Campbell of James River Adventures updated the Board on the newly constructed batteau displayed at Riveredge Park. He said the batteau will be used for educational and recreational purposes on the James River and anticipates offering batteau rides during the week. Mr. Campbell offered to take the Board out on the batteau next spring.

D. Johnson's Senior Center - DSS

Department of Social Services Director Susan Mays updated the Board regarding Johnson Senior Center's announcement of closing on November 19, 2018.

Ms. Mays advised that another management service, Life Care Management, has offered a contract with Johnson's Senior Center to serve as a consultant until March 2019. She reported that Johnson's license will expire December 2018, and pending corrections of infractions, would allow the center to stay in business.

Ms. Mays provided an outline of the cost to operate an emergency shelter if needed for displaced residents. She explained the Virginia Department of Social Services is overseeing a possible transfer of ownership, however, Amherst DSS would be responsible to manage resident care for those who are not relocated. The monthly costs could be:
