IN RE: ENGLAND STOVE/FITZGERALD NOISE COMPLAINT

C. Hudson, President of England Stove, and the Fitzgeralds have been invited to discuss progress England Stove has made as to remedying the Fitzgerald's noise complaints.

Present – Mr. C. Hudson, England Stove Works Mr. & Mrs. Fitzgerald Rich Warner, neighbor

Mr. Hudson proceeded to disclosed what they have done to try to remedy the problems as seen by the Fitzgeralds. They had changed the bearings in the dust collector. They have enclosed the external dust collector with nine-inch thick, insulated siding, at considerable cost. They will change the

bearings again this Friday, as part of their yearly maintenance. The obnoxious odors no one else has complained about any odors from England. They have planted 50 Leyland Cypress trees but need to wait until spring of 2010 to finish planting due to weather. The dumpster has been removed. They believe the County's vegetative buffer and the recently planted Leyland Cypress trees along the eastern edge of the property should be sufficient to adequately conceal the wooden pallets. It is believed that with the County's vegetative buffer (one line of Leyland Cypress trees, with one parallel line of Pine Trees in front of it) should be enough, when mature.

Mr. Fitzgerald – Leyland Cypress will not help him in his life time. He wanted to know if that's all he's going to do regarding the noise. He hold the county responsible for allowing noise near homes.

The Board directed Mr. Hunt and Mr. Proffitt to return to the property check out the level of the noise now and on how the trees are planted and the number that needs to be replaced. Also to check on the pallets to see what might be done to conceal the pallets any more and return back to the Board of Supervisors at their next meeting.

In April of this year a 2002 Chevrolet animal control pickup was declared a total loss as a result of an accident. The County has been compensated in the amount of \$11,520 by VACo Insurance. Animal Control has been short staffed by one animal warden during most of that time and the vehicle replacement has been delayed while waiting for issuance of new vehicle state contracts. Since the new

warden has been hired, Bart Shaw has been using a county pool vehicle in conjunction with his personal vehicle. The new contract is now available for a $\frac{1}{2}$ -ton, 4x4, extended cab Chevrolet pick-up. The cost of the truck is:

IN RE: AMELON COMMERCE CENTER MASTER PLAN

Mr. B. Hopkins appeared before the Board with the master plans for Amelon Commerce Center. He proceeded to go over the plans with discussion and questions from the Board of Supervisors.

By consensus the Board of Supervisors directed staff to place the Request for Sewer Line Extension to Lots 5 and 6 and Parcel 1 of the Amelon Commerce Center Resolution on the first meeting of November agenda.

IN RE: STATUS OF CODIFICATION OF REVISED PARK RULES

The County Attorney presented to the Parks and Recreation Board a draft copy of the Revised Park Rules for recommendation for codification by the Amherst County Board of Supervisors into the

Amherst County Code. The PRB took no action on the Revised Rules. Upon information and belief, the PRB did not take any action, because (inter alia) they: (1) needed additional time to review the Revised Rules; (2) desired to informally poll their constituents as to the Revised Rules: (3) desired to ruminate longer as to a possible prohibition of certain length boats from launching at the Monacan Park boat ramp; and (4) desired additional information as to punishment for violation of park rules.

Mr. C. Adams recommended to invite DGIF, Recreation Board representatives and Sheriff's Department representatives to attend a meeting in get further information regarding the problem.

IN RE: PHELPS ROAD SCHOOL SECURITY UPDATE

At the last BOS meeting, Supervisor Adams requested staff to investigate security concerns at the Phelps Road School. Mr. Adams additionally requested an update as to the timetable Dennis A. Gibbs, the current owner of the school, had to complete certain events to the school. On Wednesday, September 23, 2009, Mr. French voice mailed me that the School's doors had been secured.

As to Gibbs' timeframe for completion of certain events at the school, a Memorandum of Understanding outlines his obligations as to the school. Per the MOU, Gibbs must do the following in the following timeframe:

- 1. Complete the initial research and surveys of the school within sixty (60) days after execution of the MOU:
- 2. Following completion of number 1, execute an Agreement that would transfer ownership of the school to an entity owned and controlled by Gibbs:
- 3. Secure the school and remove all debris from the school within twelve (12) months of the transfer of ownership of the school from the county; and
- 4. Make the school building deemed appropriate for renovation weather tight within twenty-four(24) months of the transfer of ownership of the school from the county.

Please be advised that ownership of the school was officially transferred to Gibbs on June 9, 2009.

IN RE: UPDATE ON SUPERVISOR VANDALL'S LIST OF ZONING NON-COMPLIANT PROPERTIES AND/OR PROPERTIES WITH JUNK CARS

- 4. White metal building on corner of Coolwell Road/29 directly behind the Quick-E Mart; building is unsafe and about to collapse and has at least 3 junk cars pars parked thereon)

Email from Deputy Givens 9/24/09 – Letter sent to the address 128 Eastview Dr and served a letter on the owner of 1935 S. Coolwell Rd. He's working on the one across from 1715 S. Coolwell. He's trying to locate the correct address and owner.

Report from K. Campbell - As of today (8/29/09) I cannot have the white building on the corner of Coolwell town down. I walked all the way around the building (not seeing the No Trespassing signs until I came out of the weeds) and although a lot of the siding is bent and looks bad, there is wood siding on the structure behind it. All the windows are intact and are boarded up from the inside and the doors are secure. If more of the roof turns loose and becomes a danger to traffic, then I might have some recourse to condemn it and have it torn down, but as it is now I legally can't under the International, State and Local Codes.

IN RE: REPORT OF LOCAL GOVERNMENT ATTORNEY'S OF VIRGINIA'S AD HOC COMMITTEE ON NOISE ORDINANCE

Report of Local Government Attorneys of Virginia's Ad Hoc Committee on Noise Ordinances represents the most comprehensive collection of information to date of or related to post-Tanner Virginia Noise Ordinance issues. The report contains the following information:

1. Summary of the Tanner Decision;

- 2. Evidentiary Issues with Decibel-Based Ordinances;
- 3. Potential Issues with the Use of Civil Penalties:
- 4. Committee Recommendations;
- 5. Option A: Virginia Beach Noise Ordinance
- 6. Option B: Town of Blacksburg Noise Ordinance; and
- 7. Source document

The LGA recommends localities adopt Noise Ordinances based on either of these two options. Option A, "Virginia Beach's Noise Ordinance (adopted in May 2009), provides for the use of decibel meters as well as enumerated standards. "Option B", Blacksburg's Noise Ordinance (adopted in September 2009), does not use a decibel meter approach; instead, it enumerates standards that prohibit noise in specified circumstances.
