#### I. Call to Order

At a Regular Meeting of the Amherst County Board of Supervisors held on March 17, 2020 at 7:00 p.m., the following members were present:

Chair Tucker called the meeting to order at 7:00 p.m.

## II. Approval of Agenda

By motion of Supervisor Pugh and with the following vote, the Board amended the agenda by deleting Item XV. Closed Session regarding the interviews of potential appointees to the Amherst County Service Authority Board of Directors.

#### III. Invocation and Pledge of Allegiance

Chair Tucker led the Invocation and Pledge of Allegiance.

#### IV. Citizen Comment

Ms. Leslie Gamble of Amherst, Virginia addressed the Board regarding the Village District along Rte.130. She spoke as a member of the Board of Zoning Appeals and Planning Commission, and said that the Village District is designated as a scenic by-way along Rte. 130. She was concerned that residents who live on the other side of the Rte. 130 corridor would be plagued with the possibility of a "hideous" cell phone tower blocking their view of Tobacco Row Mountain. She was also concerned about the store fronts and signage that should be amiable to the Village District. She did not want to see the Village District end up with signage like Madison Heights that competes for visual attention.

Ms. Gamble also addressed the Board regarding kennels and a special exception for a business to train attack dogs. She visited this location and advised there were no signs posted on the property to warn people of the danger of these dogs. She said the County should demand that signage be posted and was advised that the owner would install an electric fence, which she believed would not be much of a hindrance to contain these dogs.

Ms. Gamble said that because County ordinances are like domino effects that what Animal Control does connects with the land use, she would strongly recommend that the Board put together a task force to go through the Comprehensive Plan to line up County ordinances so "we are all are operating off the same page".

Chair Tucker asked the County Administrator to remind the County Attorney that this request was noted in public comment.

#### VII. Old Business

#### A. Brush Hauling - Public Works

Public Works Director Brian Thacker addressed the Board regarding removal of brush containers and a date to enact that. Mr. Thacker asked the Board to consider expanding the hours of operation for the landfill on Saturday from 8AM to 4PM beginning April 1.

Vice-Chair Moore asked about any increased costs to personnel by extending the hours on Saturdays.

Mr. Thacker explained an adjustment would be made to the current work schedule and distribute staff so as to not to incur comp time.

By motion of Supervisor Martin and with the following vote, the Board approved April 1st as the date to remove the brush cans and to extend the landfill hours on Saturday from 8:00 a.m. -4:00 p.m. starting on April 1st.

#### VIII. New Business

#### A. Pre-Trial and Local Probation Services

County Administrator Rodgers asked the Board to approve a resolution to apply for a grant to expand local probation and pretrial services in Amherst County. This would not create an additional financial burden to the County and may divert people from going into the jail and reduce those having to go back into that facility.

By motion of Supervisor Pugh and with the following vote, the Board adopted the draft resolution as presented and authorized the County Administrator to notify the Department of Criminal Justice Services that Lynchburg will be submitting our application.

#### B. Appropriation Request - Public Works

Public Works Director Thacker explained that the landfill track loader needed repairs. The estimated cost for repair on site is \$35,000. He advised there would be no break in landfill operations as this repair would be done over the weekend.

By motion of Supervisor Ayers and with the following vote, the Board appropriated funds not to exceed \$35,000 from the Solid Waste Fund Balance for repairs to the landfill track loader.

## C. Off-Site Recycling Containers

Public Works Director Thacker addressed the Board and advised that all convenience centers have recycling capabilities, however, the County has two external separate recycling sites at shopping centers located at Ambriar and Amelon. He advised that citizens are using those two sites for recycling as well as dumping household trash, waste and tires.

Mr. Thacker recommended closure of those two recycle sites. He provided the current cost charged by Sonoco to haul those recycling cans and asked if the Board would consider removing the two external recycling sites. This would save the County approximately \$6,800 a year.

Chair Tucker agreed, however, asking that Ms. Virginia Myers who heads the "War on Trash" be contacted to get her input on this.

Supervisor Pugh said he does support the removal of the recycling containers at the two offsite locations.

Supervisor Martin believes this will actually clean up trash in the County by using the recycling containers at the convenience centers and agreed with the proposal.

Vice-Chair Moore asked if there was any feedback when the recycling bins were previously removed at Seminole Shopping Center.

Deputy County Administrator David Proffitt said he did not recall any issues.

Vice-Chair Moore asked that signage be put up at these two locations to let people know where they can take recycling.

Mr. Tacker said he would put a notice on the County website and contact Food Lion and the landlord of Amelon Shopping Center to ask for permission to post signage.

Chair Tucker asked Mr. Rodgers and Mr. Thacker to contact Ms. Myers to let her know of this action.

By motion of Supervisor Pugh and with the following vote, the Board approved removal of all eight off-site recycling containers to include Ambriar and Amelon, and that all recycle collections be redirected to the County convenience centers.

## D. Old Town Community Development Block Grant

County Administrator Rodgers addressed the Board and reported on the process of how to handle lead-based paint in the housing rehabilitation for Old Town Madison Heights Main Street Improvement Project. He explained that the expense of certain steps can be eliminated if we would consider that all paint is lead-based. The County would need a resolution to do this and it will not add any costs or delays but speed up the rehabilitation process.

Supervisor Martin understood that the County would remediate all paint as though it is lead-based paint.

Mr. Rodgers said this would allow the grant money to go further and at no cost to the County.

By motion of Supervisor Ayers and with the following vote, the Board elected to presume that all painted surfaces are lead-based paint for the purpose of complying with HUD Regulation 24 CFR 35 in conducting housing rehabilitation assistance activities for the Old Town Madison Heights Main Street Improvement Project, CDBG #17-01.
