# IN RE: AMHERST COUNTY RENTAL INSPECTION ORDINANCE

Mr. Lintecum received an email from Kelly Hitchcock, Region 2000, regarding the CDBG 2009 grant and the impact of the potential boundary realignment to the current 5<sup>th</sup> District Residential Rental Inspection Ordinance.

It has been determined that, assuming the following explanation and execution of the potential adjustment of the Residential Rental Inspection Ordinance boundaries within the 5<sup>th</sup> District is as follows, the adjustment would not impact the CDBG 2009 award.

Boundary adjustment understanding provided to DHCD for consideration:

- 1. The current Residential Rental Inspection Ordinance, passed November 20, 2007, currently applies to the entire 5<sup>th</sup> District as noted in the March 2009 CDBG application;
- 2. The potential ordinance boundary adjustment for current Board of Supervisors consideration would eliminate certain areas of the 5<sup>th</sup> District from the Residential Rental Inspection program;
- 3. The entire Old Town Madison Heights community, the geographic area roughly defined by the area located between Route 163 (Amherst Highway) on the west, Route 210 (Old Town Connector) on the north, U.S. 29 Business (Lynchburg Expressway) on the east, and the James River on the south, will continue to adhere to the 2007 Residential Rental Inspection Ordinance; and

4. The reason for consideration of the adjustment is to better apply Amherst County staff time to address those properties that prompted the ordinance.

# IN RE: ADDITION TO CHAPTER 3, ARTICLE (ANIMALS) OF THE AMHERST COUNTY CODE FOR PLACING ANIMAL CONTROL UNDER THE CONTROL/SUPERVISION OF THE AMHERST COUNTY SHERIFF'S DEPARTMENT

With the placing of the Animal Control wardens under the control/supervision of the Amherst County sheriff's Department, Chapter 3, Article I (Animals) of the Amherst County Code needs to be revised to include the following section:

#### **Animal Warden**

The Board of Supervisors shall, upon nomination of the Sheriff, appoint a special Sheriff's deputy to be known as the animal warden for the County, and deputy animal wardens whose terms of office shall be at the pleasure of the Sheriff, and it shall be the special duty of the animal warden and deputy animal wardens, subject to the supervision and control of the Sheriff's office, to enforce this chapter and the statues of the Commonwealth relating to animals, particularly the provisions with respect to dogs contained in chapter 27.4, Title 3.1, Code of Virginia. To enable them to discharge their duties, the animal warden and deputy animal wardens shall have the power, perform the duties, and be subject to the penalties that are by law prescribed. When in uniform or upon displaying a badge or other credentials of office, the animal warden and the deputy animal wardens shall have the power to issue a summons or obtain a felony warrant as necessary, providing the execution of such warrant shall be carried out by any law enforcement officer as defined in Section 9.1-101 of the state code to any person found in the act of violating any animal protection and control laws of the Commonwealth or any animal protection and control ordinances of the County.
