**BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST, VIRGINIA:**

**WHEREAS**, Section 13-3 of the Amherst County Code provides that tipping fees for the disposal of solid waste at the Amherst landfill are to be set by the Amherst County Board of Supervisors by resolution; and

**WHEREAS**, after careful review and consideration of all expenses attributable to the operation of the landfill by Amherst County, the Amherst County Board of Supervisors now deems it appropriate to revise its current fee schedule to offset increased costs of operations.


**NOW, THEREFORE, BE IT RESOLVED** by the Amherst County Board of Supervisors that the following rates and fees for services at the Amherst landfill shall become effective October 1, 2023:

Over 12 tires per year	\$275.00 per ton
 <b>CONSTRUCTION/DEMOLITION</b>	
• Standard Rate	\$53.00 per ton
Less \$9.00 business credit	-\$9.00 per ton

Discounted rate	\$44.00 per ton
CLEAN YARD WASTE/WOOD	\$34.00 per ton
COMMERCIAL RESIDENTIAL	\$44.00 per ton
COMMERCIAL RESIDENTIAL LICENSE	\$250.00 per vehicle
COMMERCIAL RESIDENTIAL BOND	\$500.00 per vehicle
CIVIL PENALTY: SECURING & COVERING LOAD	\$500.00
CIVIL PENALTY: LITTER RECEPTACLES	\$50.00
CIVIL PENALTY: VIOLATION	\$250.00
