II. Approval of Agenda

By motion of Supervisor Martin and with the following vote, the Board approved the agenda for April 6, 2021.

III. Invocation and Pledge of Allegiance

Supervisor Martin led the Invocation and Pledge of Allegiance.

IV. Citizen Comment

There was no public comment.

V. Ordinance - First Read

A. Ordinance No. 2021-0005, amending Sec. 1102 addressing site plan review.

Community Development Director Jeremy Bryant presented an amendment to County Code to modify the site plan review procedure. Mr. Bryant explained this change would allow staff to review and approve by-right site plans without approval by the Planning Commission. Mr. Bryant advised this modification was approved by the Planning Commission at its March 2021 meeting.

By motion of Supervisor Ayers and with the following vote, the Board authorized staff to advertise Ordinance No. 2021-0005 for a public hearing.

Mrs. Brown stated the current ordinance identifies Grace Baptist Church as the voting polling place in Election District 1, Wright Shop Precinct. She advised the correct name should read Scott Zion Baptist Church.

C. Ordinance 2021-0007, amending Litter ordinance relating to penalty of securing and covering loads.

County Attorney Mark Popovich presented a proposed amendment to Ordinance 2021-0007. He stated the County has a current ordinance regarding the penalty of securing and covering loads. He said that in order to be in compliance with the Code of Virginia, an amendment to the existing ordinance is necessary to increase the penalty from \$250 to \$500.

Supervisor Martin asked how many tickets have been written under the current ordinance and asked if raising the penalty would have an effect.

Mr. Rodgers advised he would research that and indicated the Coalition for a Cleaner County has asked for an increase in penalty fees.

VII. Special Presentation

A. Presentation of the FY 2020 Audit

Ms. Susan Chapman of Brown Edwards presented 2020 County audit and advised the County had a "clean" audit with an unmodified opinion. She reported there were no major concerns and material weaknesses.

Ms. Chapman addressed three adjustments that were made for the year that included the School debt was paid off in the jointly-owned assets; a correction was made to an EDA depreciation issue; and adjustments were made to accounts receivables.

Ms. Chapman reported there were no material weaknesses, however, there were deficiencies in separation of duties and the inability to split duties using the current software. She said there were no other major concerns to report.

Vice-Chair Pugh nominated Larry Langhans as the District 4 representative.

IX. New Business

A. Boards/Commissions/Committees - Building Appeals Board 2018 Charter

Building Official Nate Young addressed the Board with a proposed amendment to the Building Appeals Board Charter that voting members become at-large members instead of representing a specific election district.

Mr. Young said due to increased hardship in finding qualifying citizens, the County Attorney recommended removing the election district requirement and making all member representatives at-large.

C. Amherst Rescue Squad Corporation

County Administrator Rodgers advised that Amherst Rescue Squad is preparing to dissolve its corporation and the Articles of Incorporation state that any remaining assets be distributed to Amherst County and the Town of Amherst.

Mr. Rodgers said two members of the Board will need to be appointed to meet with representatives of Amherst Town Council and the Amherst Rescue Squad Corporation. This will allow group discussions to resolve any issues that may result from the dissolution.

Supervisor Tucker stated she wished to appointed.

Supervisor Martin nominated Supervisor Ayers.

By motion of Supervisor Tucker and with the following vote, the Board appointed Claudia Tucker and Jimmy Ayers to satisfy the Town Council's request.

D. Marijuana Legislation

County Administrator Rodgers addressed the Board regarding a request by Supervisor Ayers to discuss legislation adopted by the General Assembly concerning the legalization of marijuana.

County Attorney Popovich said the issue before the Board is to decide whether or not to allow dispensaries in Amherst County. He said this would not change the fact that marijuana can be personally used in the County.

Supervisor Tucker asked about a possible referendum to allow marijuana and the dispensing of it in the County.

Mr. Popovich said a referendum would not address the legality of marijuana, however, he asked the Board if the County wants to impose regulations on where dispensaries would be located and to impose certain taxes on sales.

Mr. Popovich said there is a limitation of the number of dispensaries that the State will allow, which is 400 for the entire state, as well as how many permits will be issued. He also said there will be a limitation of 25 wholesalers, 60 manufactures, and 450 cultivation farms and facilities. Furthermore, he said the referendum would be for County citizens to decide whether they would want any of those to come into the County.

Supervisor Ayers commented that he has seen families impacted by marijuana use and was not supportive of this. He said he does support citizens having a say whether they would want to make dispensaries a part of this community.

Vice-Chair Pugh and Supervisors Tucker and Martin were all in agreement.

By motion of Supervisor Martin and with the following vote, the Board directed staff to work with the Amherst County Registrar, monitor the current legislation, and place this issue on the November ballot, if feasible, for a referendum to authorize the establishment of dispensaries and manufacturing facilities as permitted by recently adopted legislation.
