I. Call to Order

At a regular meeting of the Amherst County Board of Supervisors held on March 15, 2022 at 7:00 p.m., the following members were present:

Vice-Chair Martin called the meeting to order at 7:00 p.m.

II. Approval of Agenda

Vice-Chair Martin made an amendment to the March 15, 2022 Agenda and requested to strike Section XI. Items A. and B. due to Supervisor Tucker's absence.

By motion of Supervisor Wade and with the following vote, the Board approved the amended agenda for March 15, 2022.

III. Invocation and Pledge of Allegiance

Supervisor Ayers led the Invocation and Pledge of Allegiance.

IV. Citizen Comment

Mr. Gregory Snyder of Waughs Ferry Crossing, addressed the Board regarding the repair of this road. He said VDOT advised him this would have to go through the Board of Supervisors. Mr. Snyder said he lives on a one-half mile of unpaved road that is nothing but fine dust and is requesting this road be repaired.

Mr. John Furry of District 5 addressed the Board regarding the Riveredge Park Vista project and the condemnation of citizens' properties. He said he read the mission statement of the Board that said to "increase citizen engagement". He has not seen any of this regarding the park project to date. The resolution that was passed by the Board was vague and was covered under the statement of "recreation".

Mr. Furry proposed several questions to the Board regarding the cost and need for this project. He said it would be difficult and expensive to put something on this cliff and a zip line so close to the railroad, and not to mention the extra traffic added to those streets, safety issues and the zoning.

Mr. Furry stated that there was no evidence presented of any kind of study before the Board passed the resolution. He suggested the public needs to be involved and asked that the Board provide information for the community to access.

The Citizen Comment session was closed.

V. Public Hearing

A. Public Hearing on Virginia Public School Authority (VPSA) General Obligation Debt Financing

R. T. Taylor of Davenport presented information to the Board to obtain financing from the Virginia Public School Authority Spring Pool (VPSA) to pay for the high school renovations. In December 2020, he worked with staff to analyze the various school construction projects and how to use \$19.6M for this construction.

Mr. Taylor presented three different scenarios to analyze how the county would use the "one-time" county and school moneys.

Mr. Taylor said the proposed resolution would direct the County to use VPSA Spring Pool funding, and that the bonds would be priced on or about April 22 and would close on May 17.

Community Development Director Jeremy Bryant presented Special Exception 2021-594 by Grant Massie for two special exceptions for short-term tourist rentals; one dwelling located at 503 Woodson Road and the second located at 505 Woodson Road.

Mr. Bryant said that both dwellings have direct access to a state-maintained road, and advised the Planning Commission had recommended approval with noted conditions.

D. Special Exception 2022-051 Joseph Jerina Community Development Director Jeremy Bryant presented Special Exception 2022-051 by Joseph Jerina for an auto repair garage and a towing operation located at 128 Old Town Connector.

Mr. Bryant advised that staff is working on revisions to the site plan with the applicant that will address a reduction in the size of the entrance and add landscaping across the front.

Community Development Director Jeremy Bryant presented information on the steps of revocation of a special exception permit. He advised this process would be evaluated by the Planning Commission, staff and through a public hearing process.

Mr. Bryant said this would be based on use, lack of conditions or lack of follow-through when special exceptions are approved.

The proposed ordinance would allow the Board of Supervisors to revoke a permit by resolution, which would include a review by the Zoning Administrator and the Planning Commission. The Board of Supervisors would then make a final decision.

VII. Special Presentation

A. Firefly Broadband Fiber Buildout Plan Mr. Gary Wood and Ms. Melissa Gay of Firefly Broadband addressed the Board and provided an update on Firefly's fiber buildout plan.

Mr. Wood said Amherst County has been very supportive of the VATI application. He provided information on areas that are connected, including the Gladstone and Colleen substations. He also identified completed areas as the CARES Act projects, which include Boxwood Farm Road, Gladstone, Roses Mill, Flatwood and Warwick Barn.

Mr. Woods explained that Ms. Melissa Gay, Communications Manager, would address the next build-out plan.

Ms. Gay addressed the Board and advised that they would be working in the Temperance area. She said a hut would be placed in that area including Little Piney, Indian Creek, Winton, Hartless Road, Geddes Mountain and Toytown. Those areas are scheduled to be connected in the winter and spring in 2023. She said Firefly would be built from Temperance to Elon, Madison Heights and Stapleton for completion by fall of 2023.

Mr. Woods advised that the maps on their website would be more accurate and Firefly's goal is to make sure people who do not have internet service would be provided a service at a competitive price.

B. Animal Shelter Operations Captain Juette Renalds of the Amherst County Sheriff's Office, and Mr. Tony Cerqua of the Humane Society, addressed the Board regarding the animal shelter operations.

Captain Renalds said their process is to evaluate and make decisions that involve euthanizing in order to provide the healthiest animals to the Humane Society for adoption. He commented that there is a space issue, but we have treatment options to ensure the survival of the animal.

Mr. Cerqua said the Humane Society is fueled by donations and the thrift store that they operate. He said no Board members are compensated for personal expenses and the Humane Society is not affiliated with other organizations.

Mr. Cerqua explained the process of how the animals are assessed before adoption. He reported they are involved in transferring dogs and cats in rescue vans that travel to the northeast.

Vice-Chair Martin asked County Administrator Rodgers to bring back to the Board a proposal that would increase the spay and neuter program in Amherst County.

VIII. New Business

A. Redistricting Committee

Community Development Director Jeremy Bryant reported to the Board that the Redistricting Committee was formed to address the 10-year Census requirements. It is required that the population of each district be within a 10 percent deviation of each other. He said the 2020 Census found there was more than a 10 percent deviation that occurred between District 4 and District 5.

Mr. Bryant thanked Registrar Fran Brown and Mrs. Leslie Gamble who both spent time on the Redistricting Committee, as well as the two youth who were also part of the committee.

He advised the Redistricting Committee proposed two options: Option 1 being less disruptive to citizens and closer to their current voting precinct; and Option 2 being more disruptive to citizens by crossing property boundaries.

The Redistricting Committee recommended Option 1, which would be the least disruptive to citizens voting at a precinct near their home. It would move census blocks 3002, 3012, 3013, 3014, and 3017 from District 4 to District 5, totaling 453 citizens.

County Attorney Mark Popovich said the General Assembly adopted legislation in response to the decision by the U.S Supreme Court regarding the preclearance process, and Virginia adopted the legislation by proposing one of two ways to change redistricting boundaries: 1) a public process including public involvement, meetings, and public hearings; or 2) a more streamlined process to request a recommended change to the Attorney General's Office to analyze for legal compliance, which would allow the county to proceed to hold a public hearing to revise the voting district boundaries. These changes must be made within 60 days.

By motion of Supervisor Wade and with the following vote, the Board directed the County Attorney to present Option 1, changing the boundary between Districts 4 and 5, to the Virginia Attorney General's Office to review and certify with no objection the proposed redistricting boundaries as permitted by Section 24.2-129 of the Code of Virginia.

XII. Departmental Reports

A. Amherst County Museum & Historical Society - Annual Report Director Octavia Starbuck addressed the Board and provided an annual report on the Museum. Past President Cynthia Hicks and Vice-President Midge Elliott were also present.

Mrs. Starbuck explained how COVID affected the museum during the past two years. She reported that the museum was increasing activities once again, and in particular, hosted an open house for the Monacan Nation's new exhibit launched in November 2021.

Mrs. Starbuck provided statistics on individuals who contacted the Museum for research, resources and files on Amherst County.

Mrs. Elliott reported the Museum now has new signage that has been installed on the building and out front of the yard.

The Board thanked Mrs. Starbuck, Mrs. Hicks and Mrs. Elliott for the good work that the Museum is doing in the community.
