I. Call to Order

At a regular meeting of the Amherst County Board of Supervisors held on November 15, 2022 at 7:00 p.m., the following members were present:

V. Call to Order- ACSA

Vice-Chair Martin called the ACSA Board to order.

VI. Public Hearing

A. Ordinance 2022-12, ACSA Availability Fees Assessment

Bob Hopkins, Service Authority Director, presented Ordinance 2022-12 to the Board. Amherst County Service Authority is planning a change to its method of assessing water and wastewater availability fees. The current method is to base the fees on the estimated average daily water use planned by the applicant. The change will replace that with assessing the fees by water meter size; because ACSA does not meter wastewater, but bills for wastewater service using the water bills, this change will also apply to wastewater.

The Public Hearing was opened.

Proponents: Calvin Kennon addressed the Board and stated he is very much in favor of this ordinance. He stated this would be a big win for Economic Development.

C. Special Exception 2022-489 Inmer Estrada

Tyler Creasy, Assistant Zoning Administrator/Planner, presented Special Exception 2022-489 to the Board. The applicant, Inmer Estrada has proposed a granite business with outside storage off of N. Amherst Hwy. Per section 707.03.1 of the Amherst County Zoning and Subdivision Ordinance, the bulk storage and sale of sand, gravel, or rock is a special exception permit. This public hearing is necessary for the proposed use to be approved.

The Public Hearing was opened.

Proponents: Calvin Kennon addressed the Board and stated he believes this will be a very valuable business. He stated he would like to see the Board reduce the amount of required landscaping so that the granite slabs

could be showed off and seen by those driving by.

Inmer Estrada addressed the Board and stated he is the owner of the granite business. He told the Board that they will be sure to keep everything clean and looking nice.

Bill Massencup addressed the Board and stated he is the property owner. He said he would make sure everything stays neat and tidy and he does understand concerns about the aesthetics of having the stone visible. He is concerned about the stipulation of having to plant more trees and how they can affect the stone.

D. Special Exception 2022-511 Partridge Creek, Solar LLC

Tyler Creasy, Assistant Zoning Administrator/Planner, presented Special Exception 2022-511 to the Board. The applicant, Sun Tribe Development LLC, has proposed a 10-megawatt utility-scale solar generation facility on a parcel zoned R-1, Limited Residential. Per section 703.03.16, utility-scale solar generation facilities are a special exception use in the R-1 district. Therefore, this public hearing is necessary for approval of the proposed use.

Daniel Band with Sun Tribe Development gave a slideshow presentation to the Board.

The Public Hearing was opened.

Proponents: Skyler Zunk with Energy Right, addressed the Board. He stated Energy Right is a non-profit organization and they try to have a presence anywhere where clean energy conversations are taking place. He said they are appreciative of the Board's consideration of this project and if Energy Right can be of any assistance to the county to please reach out to them.

Ginger Burg addressed the Board and said she would like to ask the Board for their consideration of the solar farm.

Timothy Forrester addressed the Board and stated he would much rather see a solar farm on this property than a housing community. He stated he has a trucking company and has delivered to solar farms before and they are out of sight out of mind.

Stuart Bennett addressed the Board stating he was very excited about this project when he first heard about it. He said this is the future and he is 100 percent behind it.
