1001. Appointment of zoning administrator

This article shall be administered by the zoning administrator in accordance with the provisions herein. The zoning administrator shall be appointed by and shall serve at the pleasure of the board of supervisors County Administrator. which shall fix the compensation of the zoning administrator by resolution.

1002. Powers and duties of the zoning administrator.

1002.01. Powers and duties relating to zoning. The zoning administrator is authorized and empowered on behalf of and in the name of the board of supervisors County to administer and enforce the provisions set forth herein to include receiving applications, inspecting premises, issuing zoning permits for uses and structures which are in conformance with the provisions of this article. The zoning administrator shall have all necessary authority on behalf of the board of supervisors County to administer and enforce this article, including the ordering in writing of the remedying of any condition found in violation of this article, and the bringing of legal action, including injunction, abatement, or the appropriate action proceeding, to insure compliance with this article. The zoning administrator may, as necessary, solicit the assistance of other local and state officials and agencies to assist with the enforcement of the Zoning and Subdivision Ordinance. The zoning administrator does not have the authority to take final action on applications, nor matters involving variances not on special exceptions, on which final action is reserved to the board of supervisors or the board of appeals.

IN RE: AMHERST HISTORIC RESOURCES SURVEY INTERIM STATUS REPORT

Mr. Scott Smith with The Antiquaries, a Limited Company, presented a status report on what they had been doing regarding the Virginia Department of Historic Resources' Cost Share Grant Program. This is a partnership between the County of Amherst, Department of Historic Resources and Sweet Briar College's Tusculum Institute.

The project goals:

- Conduct 275 Reconnaissance Level Surveys (or equivalent) of historic resources within County that had not already been surveyed.
 - Recon Surveys include:
 - Brief exterior description
 - 3-6 exterior photos
 - Site plan
 - Topographic map
- Create a Survey Report Book documenting findings

Project Outcomes to Date

- Team has conducted approximately 295 actual recon surveys, and an equivalent of 319 (a preliminary information for, or "PIF" for any potential historic district, is "worth" 12 recon surveys.
- Team has identified two potential rural historic districts, Pedlar Mills and Sandidges.
- Team has driven every public road in Amherst County, and many private roads
- Distribution of resources documented is wide

Mr. J. Bryant presented case 2010-03 that was continued from the April 20, 2010 Board of Supervisors' meeting. The Planning Commission recommended approval with the following conditions of a special exception in the R-2 General Residential District:

- 5. The use of the manufactured home shall only be used by Charles Ray Knowles, Sr. Once Mr. Knowles is no longer residing in the manufactured home, it shall be removed from the property.

IN RE: 2009-25 PLANNING COMMISSION MEETING GUIDELINES

Mr. J. Bryant presented a set of meeting guidelines to be adopted to the Amherst County Planning Commission Charter as follows:

Public Hearing Guideline

Public hearings may be held at either of the two (2) scheduled monthly meetings of the commission, but are typically held on the second meeting of each month.

The purpose of a public hearing is to allow public comment on potential county zoning code changes, rezoning, conditional zonings or special exceptions or other public hearing items as may be prescribed by the Code of Virginia.

The following procedural guidelines shall be used to expedite the hearing process:

- Petitioner, applicant or representative will be given a maximum of ten (10) minutes to present a proposal. Proposals should be submitted in advance to provide the Planning Commission members an opportunity to review the documents prior to the commission meeting.
- 2) A period of public comment will be available to permit supporting or opposing opinions to be presented. Persons planning to speak, should sign the "sign in sheet" located at the meeting room entrance. Lengthy¹ commentaries should be presented in hard copy form to expedite the process. Each speaker will be allowed three (3) minutes to present their comments.
- 3) The commission would prefer that speakers with repetitive opinions select a single spokesperson to present their case and have a show of hands by all other supporting persons.
- 4) Once all public hearing comments have been heard; the chairman will close the public hearing. The commission may go into a business session during which the public may remain present, but will not participate in the discussion unless requested by the commission.

Guidelines for non-public hearing items of the Planning Commission:

- a) Presentations should be directed to planning and zoning matters. Expressions of concern about specific zoning or development matters should be submitted in written form to the Planning Director prior to the commission meeting.
- b) Presentations should be acknowledged by the chair person for only those items not applicable to "By-Right" development items.
- c) Presentations by the applicant or questions from the Planning Commission to the applicant or his or her designee should be presented in an efficient manner, with an overall comment period limited to five (5) minutes. The planning Commission Chairman may allow discussion to exceed five (5) minutes if necessary.

The Board will comment on the above guidelines at the June 3 joint meeting with the Planning Commission.
