§ 62.1-44.15:51

"Land-disturbing activity" means any land change that may result in soil erosion from water or wind and the movement of sediments into state waters or onto lands in the Commonwealth, including, but not limited to, clearing, grading, excavating, transporting and filling of land, except that the term shall not include:

- 1. Minor land-disturbing activities such as <u>home gardens</u> and individual home <u>landscaping</u>, <u>repairs and maintenance</u> work;
- 2. Individual service connections;
- 3. Installation, maintenance, or repair of any <u>underground public utility lines</u> when such activity occurs <u>on an existing hard surface road</u>, street or sidewalk provided the land-disturbing activity is confined to the area of the road, street or sidewalk that is hard surfaced;
- 4. <u>Septic tank lines or drainage fields</u> unless included in an overall plan for land disturbing activity relating to construction of the building to be served by the septic tank system;
- 5. Surface or deep mining activities authorized under a permit issued by the Department of Mines, Minerals and Energy;
- 6. Exploration or drilling for oil and gas including the well site, roads, feeder lines and off-site disposal areas;
- 7. Tilling, planting or harvesting of agricultural, horticultural, or forest crops, or livestock feedlot operations; including engineering operations as follows: construction of terraces, terrace outlets, check dams, desilting basins, dikes, ponds, ditches, strip cropping, lister furrowing, contour cultivating, contour furrowing, land drainage and land irrigation; however, this exception shall not apply to harvesting of forest crops unless the area on which harvesting occurs is reforested artificially or naturally in accordance with the provisions of Chapter 11 (§ 10.1-1100 et seq.) of this title or is converted to bona filed agricultural or improved pasture use as described in subsection B of (§10.1-1163);
- 8. Repair or rebuilding of the tracks, right-of-way, bridges, communications facilities and other related structures and facilities of a railroad company;
- 9. <u>Agricultural</u> engineering operations including but not limited to the construction of <u>terraces</u>, <u>terraces</u>, <u>terrace outlets</u>, <u>check dams</u>, <u>desilting basin</u>, <u>dikes</u>, <u>ponds</u> not required to comply with the provision of the Dam Safety Act, Article 2 (§ 10.1-604 et seq.) of Chapter 6 of this title, <u>ditches</u>, <u>strip cropping</u>, <u>lister furrowing</u>, contour cultivating, contour furrowing, land drainage and land irrigations;
- 10. Disturbed land areas of less than 10,0000 square feet in size; however, the governing body of the program authority may reduce this exception to a smaller area of disturbed land or qualify the conditions under which this exception shall apply;
- 11. Installation of fence and sign posts or telephone and electrical poles and other kinds of posts or poles;
- 12. <u>Shoreline erosion</u> control projects on tidal water when all of the land disturbing activities are within the regulatory authority of an approved by local wetlands boards, the Marine Resources Commission or the United States Army Core of Engineers; however, any associated land that is disturbed outside the exempted area shall remain subject to this article and the regulations adopted pursuant thereto; and
- 13. <u>Emergency work</u> to protect life, limb or property, and emergency repairs; however, if the land-disturbing activity would have required an approved erosion and sediment control plan, if the activity were not an emergency, then the land area disturbed shall be shaped and stabilized in accordance with the requirements of the plan approving authority.
