**BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF  
AMHERST, VIRGINIA:**

- I. That the Amherst County Board of Supervisors ("Board") supports applying for VCDBG Funds not exceeding \$2,000,000 to provide community improvements to the South Madison Heights Public Infrastructure Project.**

**WHEREAS,** financial assistance is available to units of local government through the Commonwealth of Virginia Community Development Block Grant (VCDBG); and

**WHEREAS,** in compliance with VCDBG requirements, two public hearings were advertised in a newspaper with general circulation in the County, and distributed among community residents by community leaders and project management team members, and the hearings were held on August 6, 2025, and August 19, 2025, regarding this application; and

**WHEREAS,** Amherst County wishes to apply for VCDBG funds not to exceed \$2,000,000 to be used to undertake a two-year Public Infrastructure project throughout the South Madison Heights community; and

**WHEREAS,** the project is anticipated to directly benefit an estimated 57 households, of which 53.12% are low-and-moderate income according to HUD LMI Mapping Tool of Census Tract 105.04, by providing public infrastructure improvements, which will meet Housing and Community Development Act of 1974 Section 104(b) National Objective of providing benefits to persons of low and moderate incomes; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors of Amherst County, Virginia, that pursuant to two public hearings, Amherst County, Virginia wishes to apply for VCDBG Funds not to exceed \$2,000,000 to provide community improvements to the South Madison Heights Public Infrastructure Project; and

**BE IT FURTHER RESOLVED** that the Board of Supervisors of Amherst County, Virginia, hereby authorizes the County Administrator to sign and submit appropriate documents.


**II. That this resolution shall be in force and effect upon adoption.**
