IN RE: PUBLIC HEARING ON PROPOSED CONVEYANCE OF AN EXCLUSIVE EASEMENT OVER COUNTY PROPERTY FOR USE IN CONNECTION WITH A RESTAURANT, AS A DELIVERY AREA, EMPLOYEE PARKING AND BUILDING EXIST

The Chairman turned the meeting over to the County Attorney, Ellen Bowyer.

She explained what the public hearing was about and was open for questions.

Ms. Tucker: Was the Board giving a perpetual easement or an easement that could be recalled if owner changed.

Mr. Kidd called for the opening of the public hearing.

Proponents: None

Opponents: None

Public Hearing was closed.

Supervisors:

Mr. Vandall: Does not think they should issue a perpetual easement. It should be for this owner only.

On motion of Mr. Vandall and with the following vote, the Board approved to convey an exclusive easement over county owned property.

Ms. Tucker made a motion to reconsider Mr. Vandall's motion.

There was further discussion as to the meaning of exclusive easement. The County Attorney provided new wording for the easement document.

Ms. Tucker wanted it clear that this did not affect his getting a loan. Ms. Bowyer did not know but did not think so.

Mr. Vandall made a motion to approve the second easement resolution with additional wording as follows:

RESOLUTION TO AUTHORIZE CONVEYANCE OF AN EXCLUSIVE EASEMENT OVER COUNTY PROPERTY, AS AUTHORIZED BY VA CODE ANN. § 15.2-1800

BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST:

I. That the Board of Supervisors wishes to convey an exclusive easement over County-owned property, as follows:

WHEREAS, there is proposed for location in Amherst County a Vito's Restaurant, which will be located at the site now occupied by the former Amherst Mini-Mart at 188 Richmond Highway, Amherst, Virginia, 24521; and

WHEREAS, there lies behind that site a parcel of land owned by the County; and

WHEREAS, Vito's Restaurant, to ensure its safe and effective operation, requires access to that parcel of land for the purposes of receiving deliveries, accommodating employee parking, and facilitating building egress; and

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST:

That the Amherst County Board of Supervisors approves, pursuant to the authority granted to it under §§ 15.2-1800 *et seq.* of the *Code of Virginia* (1950), as amended, the conveyance of an exclusive easement over County property located behind the closed Mini-Mart at 188 Richmond Highway, Amherst, Virginia, 24521, for use, in connection with Vito's Restaurant, as a delivery area, employee parking, and building exit, which easement is approximately 118 feet in length and 30 feet in width, and would extend in length from the light pole at the southeastern corner of the Mini-Mart to the southwestern corner of the car wash, and in width from the rear of the Mini-Mart to within 10 feet of the evergreen buffer; and

BE IT FURTHER RESOLVED, that no construction or other improvement activities shall commence on the County property burdened by the easement until the deed of easement has been executed by the grantor; and

BE IT FURTHER RESOLVED, that the deed of easement shall contain terms providing for its termination upon a majority vote of the Board of Supervisors subsequent to either (i) the failure of Vito's Restaurant to begin operation at 188 Richmond Highway, Amherst, Virginia, 24521, or (ii) the grant of a rezoning or special exception permit changing the use of the dominant estate, except that such terms shall not be included in the deed of easement in the event that their inclusion renders a mortgage on the property infeasible; and

BE IT FURTHER RESOLVED, that the deed of easement effecting the conveyance shall be prepared by the grantee, but the County Attorney shall review the deed of easement, and the grantor shall not execute the deed of easement until the County Attorney has approved it as to form and legality; and

BE IT FURTHER RESOLVED, that the members of the Board of Supervisors and the County Administrator are authorized and directed to take all such actions necessary or expedient to carry out the purposes and intents of this resolution, including without limitation, the execution of any documents necessary to effectuate conveyance of the easement.

II. That this resolution shall be in force and effect upon passage.
