At a regular meeting of the Board of Supervisors of Amherst County held at the Administration Building thereof on Tuesday, the 19th day of October, 2010 at 7:00 p.m. at which the following members were present and absent:

Mr. D. Kidd, Chairman, called the meeting to order.

Mr. R. Vandall led in the invocation and pledge of allegiance.

IN RE: CITIZEN COMMENTS

Ms. Merredith M. Page, Merredith's Restaurant, 1558 Dixie Airport Road, Madison Heights, Va 24572 wanted the Board to be aware of a situation with the Building Department and Health Department. In 2007 she got a zoning permit and building permit to start work on a new restaurant and closed the one in Lynchburg. She was told that was all she needed at the time.

In 2009 she called the Health Department and was told by Mr. Simpson that she was not to start anything without the Health Department inspection. Now she is told that the drain field needs to be completely redone after she has put all her money into the renovations. The Chairman informed her that the situation would be looked into.

Ms. Kevin Irvin, VPI Extension Agent, was there to bring the Board up to date on further restructuring to be done with the Virginia Cooperative Extension Offices. Key outcomes are as follows:

- Unit coordinators reduced from 106 to 22; re-assign remaining UCs to Educator positions.
- Districts reduced from six to four.
- Eliminated district program leader positions in each district.
- Reduced unit administrative assistant positions from 100 to 22 business managers.
- Reduced administrative costs by concentrating functions at regional business centers.
- Improved two-way flow of information.
- Enabled administrative functions to be conducted at lower costs.
- Reassigned existing faculty and staff to focus on program delivery.
- Provided counties with flexibility to scale county-based local Extension staffing to their needs.
- Preserved local presence at no additional costs.
- Concentrated limited resources to maximize impacts in a region.
- Created a formal structure to enable research advances to drive educational program delivery to citizens.
- Facilitated career development opportunities and increased the skills of Extension educators.
- Created greater accountability for program impacts.
- Implemented a flexible program design that can adjust to changing priorities and local funding initiatives.
- Formalized responsibilities for local and federal government relationship development.

Ms. B. Campbell, Director, was available for questions. She stated that the auditor would be here November 8 to finalize the audit report and maybe they would have more information at that time.

Mr. Vandall and Mr. Campbell asked questions.

IN RE: COUNTY ADMINISTRATOR'S REPORTS

Tourism:

Ms. Tucker had sent an email explaining that she had talked with Ms. Nix from the Lynchburg Regional Chamber. She had informed her that money was not in the Tourism budget to participate in the Virginia State Travel Guide and was informed that they put the County in and would pick up our share of the cost. She wanted the Board to be aware of this and the Board directed that a letter of thanks be sent.

2006 Pierce Rescue Truck:

Mr. Lintecum bought the Board up to date on the progress of Monelison Fire & Rescue in regards to the payment for the purchase of the 2006 Pierce Rescue truck.

Organizational chart:

Mr. Lintecum presented the Board with an up to date County organizational chart.

Personnel issues:

Lee Day has been appointed Interim Director of Public Safety replacing John Boon who is retiring.

Sara Lu Christian has agreed to assume supervision of Holly Mills, the Director of the Museum.

Mr. Lintecum informed the Board that he had completed the evaluations of all department heads and they are in the process of evaluating those people who report to them. He informed the Board that he was trying to bring someone here so they can receive the training for personnel management.

IN RE: COUNTY ATTORNEY REPORTS

Ms. Bowyer informed the Board that more information was needed on the Panther Mountain agreement and she wanted to delete that section for her reports.

She also wanted to add two (2) other reports:

a. A resolution to instruct the County Administrator to examine the question of the feasibility of placing daily management of the County Animal Care and Control Center under the direction of the Amherst County Sheriff's Office.

BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST:

That the County Administrator is instructed to examine the question of placing daily management of the Amherst County Animal Care and Control Center under the direction of the Amherst County Sheriff's Office as follows:

WHEREAS, the Board of Supervisors recognizes the critical importance of the services provided by the County's Animal Care and Control Center (hereafter, "Center") to the County's homeless and abandoned companion animals; and

WHEREAS, the Board also recognizes the Center's severe staffing constraints; and

WHEREAS, the Board also recognizes the significant tasks facing the Center given the number of abandoned and homeless animals sheltered by the Center on any given day; and

WHEREAS, the Amherst County Sheriff's Office already has rendered important assistance to the Center by placing responsible trustees with the Center to support its daily operation; and

WHEREAS, the Amherst County Sheriff's Office is amendable to considering the possibility of its direct management of the Center.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST:

That the County Administrator is instructed to examine the question of the feasibility of, and process for accomplishing, placement of the daily management of the Center under the direction of the Amherst County Sheriff's Office. Such examination shall proceed by communicating with other jurisdictions which utilize similar management schemes and otherwise examining the management structures of other local governments, consulting with affected County staff and with the Sheriff's Office, identifying all implications of the change in the Center's daily management and otherwise examining issues impacting such a change in management.

BE IT FURTHER RESOLVED that the County Administrator is instructed to report on the status of his response to this resolution at the first meeting of the Board in November, 2010 including specifically identifying (1) other Virginia localities that employ a similar management structure, (2) any changes to County Code or regulations he believes are necessary to effect the management change, (3) any outstanding legal questions that require advice from the County Attorney, (4) obstacles to implementing management change, and (5) any next steps necessary to effect management change.

That this resolution shall be in force and effect upon passage.

Ms. Bowyer explained that if this resolution was approved, another ordinance would have to be done and a public hearing held.

Mr. Vandall asked what brought this about.

It was explained that there were issues between the Humane Society and Animal Care.

Mr. Kidd said he had talked with the director and Sheriff and feels this would be in the best interest of the County.

Ms. Tucker made a motion to put this before the Board for their consideration and to be addressed at the November 2, 2010 meeting.

b. A resolution to instruct the County Administrator to provide updated information and options for future action relative to certain specific projects and other initiatives currently before the County.

BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST that the County Administrator is instructed to provide detailed information with respect to various projects and initiatives now pending or underway in the County so as to facilitate full consideration of such projects and initiatives in the course of preparation and approval of the County budget, as follows:

WHEREAS, the Board of Supervisors recognizes the significant financial constraints now facing the County; and

WHEREAS, the Board considers its role as guardian and steward of the County finance essential to effective County operation; and

WHEREAS, there are pending in the County at least two significant projects that will have a financial impact on the County's revenues and expenditures; and

WHEREAS, the Board must have a full understanding of those projects so that it can factor the associated revenues and necessary expenditures accurately into County budget consideration; and

WHEREAS, the Board also requires a full understanding of other actual and potential initiatives and projects pending or expected to soon arise in the County so that it can factor the associated revenues and necessary expenditures accurately into County budget consideration; and

WHEREAS, the Board of Supervisors wishes to instruct its staff to provide specific information to allow the Board to gain a full understanding of those projects and other initiatives.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST that the County Administrator is instructed to provide the following information with respect to Riveredge Park, the Train Station, and the award of Community Development Block Grant (CDBG) monies: the current status of County action on those projects; the anticipated expenses the County will incur for each project over the coming five years; the anticipated revenues to the County from each project over the coming five years; the other non-monetary benefits expected to accrue to the County from each project over the next five years; any options before the Board relative to implementing the projects; and any other pertinent information.

BE IT FURTHER RESOLVED that the County Administrator is instructed to identify any other significant projects or initiatives now pending for consideration before the Board, or otherwise awaiting action prior to implementation or completion, and for each such project identify the current status of County action on the project; the anticipated expenses the County will incur for the project over the coming five years; the anticipated revenues to the County from the project over the coming five years; the other non-monetary benefits expected to accrue to the County over the next five years; any options before the Board relative to implementing the project or initiative; and any other pertinent information.

BE IT FURTHER RESOLVED that the County Administrator is instructed to report on the status of his response to this resolution at the first meeting of the Board in November, and to produce the requested information at the first meeting of the Board in December.

That this resolution shall be in force and effect upon passage.

Ms. Tucker made the motion to accept the above resolution.

IN RE: MATTERS FROM THE MEMBERS OF THE BOARD OF SUPERVISORS

Mr. R. Vandall: heard through the grapevine that the County would be receiving a million dollars from the Feds and he wanted the County Administrator and County Attorney to check into this to see whether there is a requirement that it be appropriated to the schools and what it can be used for.

Mr. R. Curd: Emergency Service Council meeting spoke on topic of insurance and wanted to know if there could be savings and wants to be placed on bid list and they were working on operational guidelines.

Mr. F. Campbell: how matters come up and do not get any more information about them Phelps Road school – wants it monitored and keep the Board informed at every meeting.

Ms. Page – miscommunication – wants things fix so this does not happen again. He does not like people coming to meetings and tells us about problems like this. Rental inspections are another problem – we adopted new language but every time he asked the building official he tells him that there is no way to keep track of rental property. He has made the suggestion that something like the Commission of Revenue personal property where you have to mark the box if it's personal or business that something like that could be used for rental property.

Mr. Kidd: things these are things to be discussed at retreat meeting

Ms. Tucker: someone needs to be checking of this and keep Ms. Page informed of anything that could be done.

Ms. Bowyer thinks this would be an administrative matter at this time.

Mr. Lintecum is suppose to check on this.

Mr. Kidd mentioned a letter from the President of the Humane Society. Also the people that were interested in the softball field at the old Madison Heights school that came to the meeting at Temperance had there been any more follow up. Mr. Lintecum replied that the Recreation Dept was supposed to be handling this.

Train Depot – where do we stand on this. Mr. Lintecum replied that they were trying to get information on the financial liability. Mr. Kidd wanted to know of any meetings with train depot management. Mr. Lintecum replied none that he knowed of. The grant had not been accepted and would not be until he could find out about the matching funds that would be needed.

Ms. C. Tucker also inquired about the issue of giving local businesses a preference in rating their bids for goods or services. Ms. Bowyer explained that this is not permissible under applicable State law. Ms. Bowyer asked whether Ms. Tucker needed a written opinion on the question; Ms. Tucker replied that a written opinion is not necessary.
