- Historic Train Depot & Potential options for public use Need \$651,379 to complete project.
- Riveredge Park Has file but needs to check to see if complete.
- Project Management Options Questions 1) Cost of money to complete? 2) Can you
  justify spending the money? Do we have internal capacity to handle these projects? If
  you don't have internal capacity to run these projects do you want to hire a project
  manager.
- Community Development Block Grant (CDBG) for Olde Town, Madison Heights......Kelly Hitchcock, Region 2000.

Two phase project, first phase is \$724,000 for 7 houses under contract. Phase two includes two additional houses. Federal Act called Safe Act is a loan to the home owner that must be repaid and the deed is held as collateral. Applicant must be physically living in the property to have priority. Project can start when county signs contract and has until February 2012. Management plan shows rules and process for houses and applicants. Jeremy Bryant is primary contact for Amherst County.

- Mr. F. Campbell issues with land use.
- Mr. R. Curd issues with communications.
- Ms. C. Tucker Chamber impressed with Board of Supervisors and their structure. She agreed needing a red list and to post it on our website so that citizens can be aware of status of projects as well.
- Ms. J. Roberson lots on table, list of things to do with due dates associated with (ex: Train Depot).
- Dr. Walker reviewed the handout that could be used as a tracking sheet for goals. Ms. J. Roberson would rather have a complete list of all projects not just listed by goals.
- Ms. E. Bowyer advised that the list could be for Board of Supervisors and administration. She stated that the Board of Supervisors would need to pull the necessary information from the combined report.
- Ms. C. Tucker pointed out that the Board of Supervisors has authority to prioritize list.
- Mr. R. Curd states that the list would help educated the Board of Supervisors on the county needs.
- Ms. J. Roberson stated that by having a list would help bring a new Board of Supervisor or staff member up to date on where the county stands on items on list. Where she could see who was responsible and go to that person to find out the status of a particular item.
- Mr. D. Kidd pointed out that the County Administrator is over all staff not the board. The Board members should go to County Administrator rather than staff directly.

Dr. Walker assisted the Board of Supervisors with designing their own status report.

## 9:15 a.m. Public Safety and Responders

Gary Roakes – Need more staff with advance skills. Call volume has increased. Problem with volunteers responding to night calls. Incentives are being considered for volunteers but it will not resolve the issue. Time in responding to calls is an issue.

Board of Supervisors request a report with call volume and drop call report. Mr. G. Roakes stated he would have it ready for the March 1, 2011, Board of Supervisors Meeting.

The Board of Supervisors asked Mr. G. Roakes, what was the number one problem? Mr. G. Roakes stated three supervisors and three paramedics.

Mr. L. Lintecum recommended that Mr. G. Roakes be on the agenda for March 1, 2011, Board of Supervisors Meeting to present his case.

Sheriff Jimmy Ayers

- Retirement cost causing recruitment problems with out of pocket expense
- Animal Control and Shelter funds-appropriate size boxes, rabies vaccinations for all shelter employees, pre-sedatives for euthanized animals
- Computer network servers
- Jail closure will still need to maintain utilities and repairs and maintenance. Future plans as to use of facility once moved.
- Unclaimed bodies of individuals who die within their jurisdictions must provide burial. Funding cut from DSS budget.
- State fund positions will be reduced with the closure of the jail facility.
- Neglect in state funding has reduced overall funding for the Sheriff's office.

Ms. C. Tucker asked Sheriff Ayers to come prepared to show self-funded budget with cuts.

Mr. F. Campbell suggested Social Services may be in need of building. Ms. E. Bowyer brought up that it is a county building and should decide the cost of funds to utilize building. Mr. L. Lintecum stated school board in need of storage.

9:45 a.m. Public Works (solid waste and grounds maintenance) ............. Teresa Nuckols, Director

- Status of Convenience Sites and the County landfill
- Recycling Feasibility for Amherst County

Teresa Nuckols – Landfill is about 275 acres. We will need to start construction on trench B by 2015 to ready for 2016 use. Need to change permit to make changes to trenches. Proposed material recovery facility where the county could make recycling first stop and landfill second stop. County would profit from the facility. County would work with Nelson County on their recycles.
