IN RE: PROCESS OF APPOINTING INTERIM AND PERMANENT COUNTY ADMINISTRATOR

The following outlines some issues the Board may wish to consider in structuring the processes to be used for appointing any interim or permanent County Administrator. As an initial matter, the Board needs to determine whether it wishes to hire an interim administrator prior to initiating the search for a permanent county administrator.

- Does the Board want to formally advertise the position i.e., via a newspaper ad or does it
 prefer some more informal mechanism of communication? Or would the Board prefer to issue a
 solicitation to known candidates? A third option is to work through a consulting firm, such as
 Springsted.
 - a. Advertise for interim newspaper and VACO and in mean time work up advertisement for County Administrator position.
- 2. How many candidates does the Board wish to consider?
- 3. How much in compensation and benefits is the Board willing to pay?
- 4. What is the desired timeline for retention of any interim administrator and subsequently a permanent administrator?
- 5. What are some of the key qualifications any candidate should have?
- 6. What is the scope and nature of the background investigation to which the Board wishes to have candidates made subject?
- 7. Does the Board want to request outside assistance with developing a formal process for the interview and selection of candidates?
