BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST:

I. That the Amherst County Board of Supervisors ("Board") wishes to issue payment formerly approved to compensate property owners for the use of land for a tower site access road, as follows:

WHEREAS, the County has placed a communication tower and equipment on Panther Mountain, and has constructed and improved an access road to the site containing that tower and equipment; and

WHEREAS, both the access road and the tower site are located on private property; and

WHEREAS, the owners of that private property permit the County's entry onto the private property, and the County is in the process of establishing a lease to formalize the parameters of that permission; and

WHEREAS, the Board of Supervisors voted on June 16, 2009, to enter an agreement with Paul Massie Saunders, Jr., and John Tatum Saunders ("Saunderses") governing County access to their property; and

WHEREAS, the Board of Supervisors voted on November 16, 2010, to compensate the Saunderses an additional \$8,000.00, for a total of \$10,000.00, for the County's use of the Saunderses' property between 2002 and 2009; and

WHEREAS, that payment was to be delivered under the terms of the signed agreement; and

WHEREAS, that agreement has not to date been finalized yet the Board wishes to proceed with issuance of compensation for the prior use; and

WHEREAS, as part of that, the Board wishes to also pay the annual rental amounts that would have been due and owing for 2009-2010, and 2010-2011.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST:

That the Board of Supervisors instructs that payment of \$12,000 – \$10,000 for use from 2002 to 2009, \$1,000 for use in 2009-2010, and \$1,000 for use in 2010-2011 – drawn from the unobligated general fund, be made to the Saunderses, in the form of in two checks of \$5,000 each, one made payable to Paul Massie Saunders, Jr., and one made payable to John Tatum Saunders, and delivered to Paul Massie Saunders, Jr., at Saunders's Surveys, Inc., 329 Crabtree Falls Highway, Roseland, Virginia 22968.

That the Board recognizes that payment for use of the road in 2011-2012 shall be made in fiscal year 2012 once the agreement is in place.

IN RE: PERSONAL PROPERTY TAX RELIEF FOR FY2012

Ms. B. Campbell presented information to the Board from Ms. L. Byers, Commissioner of the Revenue, stating that, "According to the Treasurer, Evelyn Martin, we have \$24,593.76 left in personal property tax relief from 2010. The County receives \$2,199,018.35 in tax relief from the State. The amount of tax relief funding for 2011 is \$2,223,612.11. According to State Code any monies left from a previous year for tax relief must be used only for tax relief. After running several edits of the Personal Property book for 2011, I have the following percentages for the Board to consider. As in prior years we do need to have a cushion for additional supplements that we have each year, and prior year's taxes that have not been paid. The options are:

43.75 percent \$2,209,511.01 (\$14,101.01 left) 43.80 percent \$2,212,002.53 (\$11,609.58 left) 43.85 percent \$2,214,561.56 (\$9,050.55 left)

Ms. B Campbell made a recommendation for option 2 due to personal property abatements and supplements which would provide the County with the same cushion as it has in past years. After Board discussion, the Board requested that Ms. L. Byers advise the Board of the total vehicle value used in equation and resubmit to the Board at their next meeting.

I. That the Amherst County Board of Supervisors ("Board") hereby requests that the Amherst County Treasurer provide regular reports at the first monthly meeting of the Board, as follows:

WHEREAS, the Board requests, pursuant to the provisions of Virginia Code § 15.2-2508, that the Treasurer make reports to the Board on various financial matters on a timely basis; and

WHEREAS, the Board and the Treasurer have not previously agreed on a reporting schedule or on a reporting format; and,

WHEREAS, the Board by this resolution wishes to supply guidance to the Treasurer as to the structure and content of the reports.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST:

- 1. The Board wishes to receive monthly reports in the following areas: (i) the status of the reconciliation of the County accounts; (ii) the investment of County monies, including the institution in which the monies are invested and the anticipated rate of return on the investment, (iii) the status of progress on collecting delinquent personal property taxes, and (iv) the status of collecting real property taxes delinquent for a period in excess of two (2) years.
- 2. The reports shall be supplied to the County Administrator no later than the Tuesday preceding the first meeting of the Board of Supervisors each month, beginning with the Board's meeting on August 2, 2011, so that it may be included in the Board agenda package for that first meeting.
- 3. The report with respect to the investment of County monies shall identify the amount of County monies invested in a given institution and account, the rate of return, and the amount of interest generated for the month prior to the month in which the report is presented.
- 4. The report with respect to the reconciliation of County accounts shall indicate the last date by which reconciliation was completed and identify any issues, questions, or concerns relating to the reconciliation.
- 5. The report with respect to the collection of delinquent taxes shall identify, in separate tables, delinquent taxes by the year and amount delinquent for that year for each tax parcel and taxpayer, the status of any collection actions, the type of personal property for which taxes are delinquent, and totals for each tax year, in tables styled as or similarly to the following:
