VI. Presentation of 2015 Audit

Ms. Susan Chapman of BrownEdwards presented to the Board the 2015 Audit and indicated this is her second year doing the audit for the Service Authority.

Ms. Chapman presented an overview and commented on several issues: the financial statement unmodified opinion is good; cash remains stable and did increase a little, no big drops; meeting all operating expenses (water and sewer); big changes happening with GASB 68 with adding the

pension; remarked on the management letter regarding segregation of duties and commented that some issues will be hard to resolve without additional staff, but some of these issues do overlap with the County's by about 70%; and commented the Service Authority has begun working on an accounting manual.

Ms. Chapman asked if the Board had any questions regarding the audit. She indicated she would be available by email or telephone to answer those.

Chairman Marks thanked Ms. Chapman for her report.

VIII. 2015 VDH Award of Excellence
