4. DISCUSSION WITH SHERRIFFS OFFICE AND VDOT

Mr. Don Austin, VDOT Residency Administrator, spoke briefly on VDOT's mowing circuit throughout the year, stating that the basic process is three to four times per year for primary routes (such as U.S. 29 or Virginia 130) and two to three times a year for secondary routes. Mr. Austin stated that added maintenance is limited by money, time and people.

Captain John Grieser of the Amherst County Sheriff's Office stated that a lot of the maintenance through the office is complaint driven and there is a code enforcement officer that handles these situations and the office utilizes the inmate workforce as well. He encouraged the committee to reach out to the sheriff's office if members see something of concern and the office will coordinate with the inmate workforce supervisors.

Mr. Bryant presented the committee with a ranked list of priorities for maintenance of the corridor. Mr. Bryant stated that the numbers might change with the inclusion of rankings from C.T. Wingfield, the newest member of the committee. Mr. Bryant noted that the number one priority according to the committee is signs along corridor.

Mr. Wingfield agreed that the signs may not be attractive but stated that "business owners don't waste their time just planting signs and signs are important to business owners whether you dine, shop, or saw something at a traffic light...it is really important to the business owner."

Mr. Kennon stated that the committee does not want there to be a difference of opinion of whether the sign is "hideous" or "vital" but that there should be some sort of mesh or mend where the county allows these signs in a designated area.
