Explanation of why funds are needed and where funds are coming from:

Changes reflect the final FY17 budget changes approved by Social Services Board based on revisions to state allocations and pass-thru funding; a reduction in revenue for the halted COL adjustments; and addition of Family Partnership incentive revenues. The net result is a \$42,456 increase in revenue with no additional local funds.
