The Amherst County Parks, Recreation and Cultural Development Board held its monthly meeting on September 10th, at 6:30PM at the Monroe Community Center.

The following members were present: Chairman Stevie Angus, Roni Tuggle, Christy Krueziger, John Mann and JoJo Allcock. Also in attendance was Sara Lu Christian.

The meeting was called to order by Stevie, Chairman.
