BOARD MEETING
April 9, 2018

The Amherst County Parks, Recreation & Cultural Development Board held its monthly meeting on April 9, 2018 at 6:30PM at Monroe Community Center.

The following members were present: John Mann, Roni Tuggle, Christy Kreuziger, JoJo Allcock and Stevie Angus. Also in attendance was Sara Lu Christian

The meeting was called to order by Chairperson Stevie Angus.

Roni made a motion to approve the agenda, Christy seconded the motion. Motion carried

JoJo made a motion to approve February minutes, Christy seconded the motion. Motion carried.

Sara Lu reported that the Eagle Scout project as presented at last month's meeting was deferred to the Public Works department.

The Board reviewed the senior social calendar and reports, and bingo reports. Today was the first Social for Seniors for the 2018 calendar year and held at the Madison Heights Community Center. There were roughly 175 seniors in attendance.

The Board also reviewed the community centers calendar, and theme park and night fishing license reports.

Sara Lu raised the subject of installing a Virginia is for Lovers "LOVE" sign at Riveredge Park. Christy expressed concern over this. The matter will be discussed at the next Board meeting.

Sara Lu reported on the condition of the picnic tables at the county lakes. These tables are over 30 years old, are worn and weathered, and should be replaced. The matter is going to the Board of Supervisors for direction.
