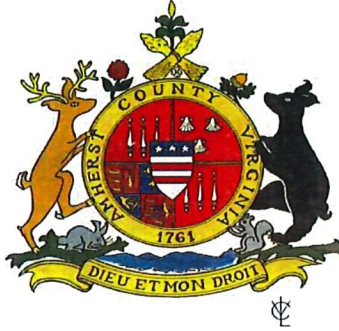


Town Manager Sara Carter made a presentation of the proposed “Town Square” Development.
