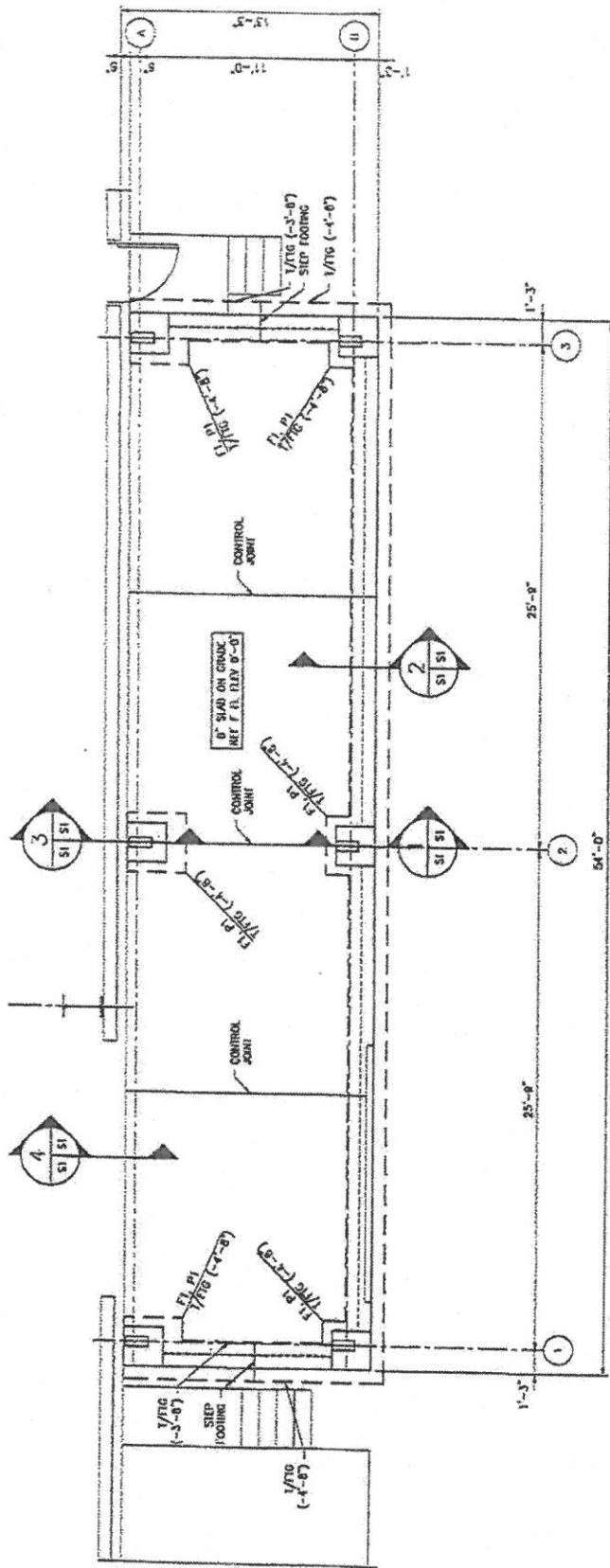

SCALE: 1/4"=1'-0"

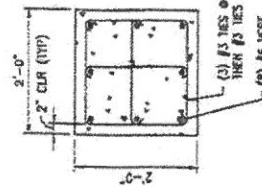




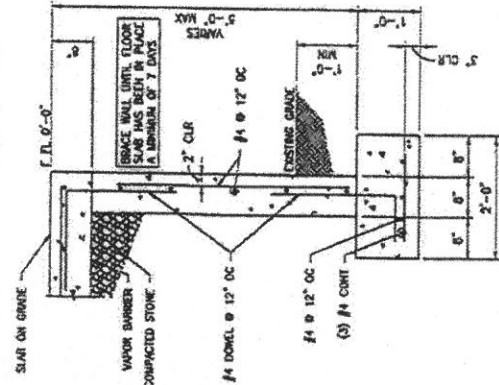

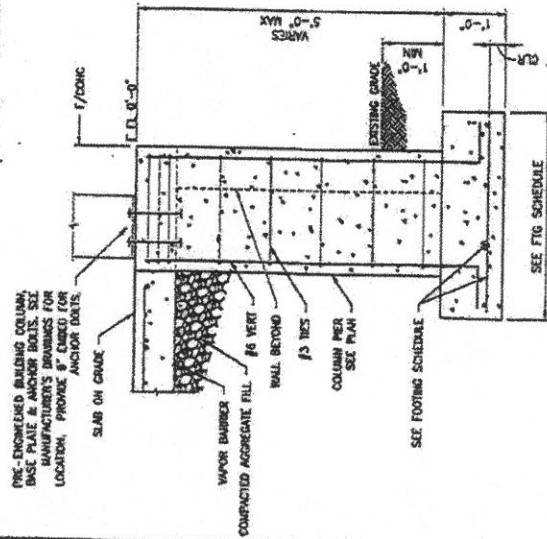
PIER SCHEDULE

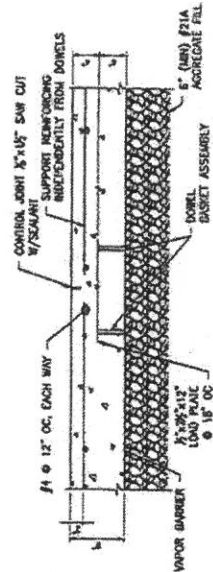
PIER DETAIL

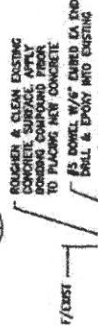
SECTION 2

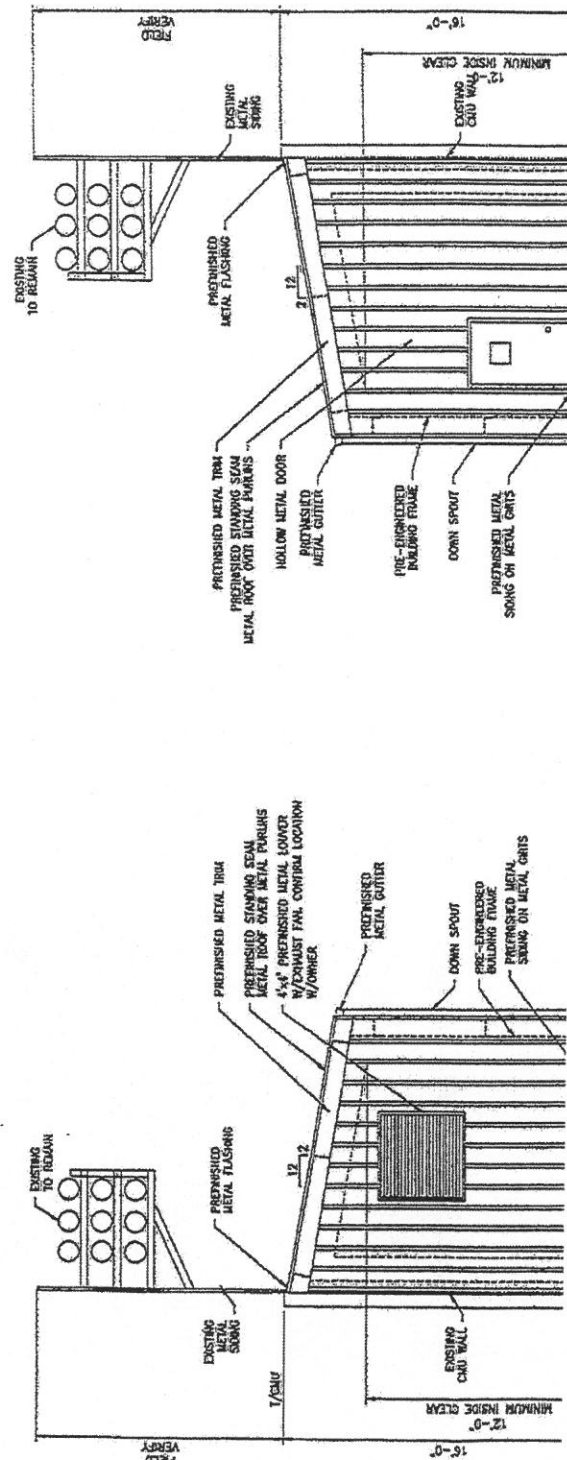
SECTION 1
