XII. New Business

A. Business Equity Tax Changes

County Administrator Rodgers reported on changes to the County's taxation addressing three problems:

- 1) Movement of inventory out of the county to avoid Merchant's Capital tax;
- 2) Institute more realistic depreciation rates for Machinery & Tools/Business Equipment tax;
- 3) Make changes that are revenue neutral and do not overburden small businesses with high gross receipts and low margins ("mom & pop shops").

Supervisor Pugh suggested Town Hall meetings and advertising to notify County citizens.

It was the consensus of the Board that information explaining the tax changes be included in next year's tax bills, and advertising for Town Hall meetings be scheduled to inform the public.

B. County Fair Funding

Mr. Jeff Floyd, Chairman of the AG Committee addressed the Board and asked for funding for the 2020 Amherst County Fair and Fair Director.

Supervisor Tucker stated that the County needed to give the Committee the tools to be successful.

Supervisor Pugh said he would like to see more agricultural pursuits and did not see any money paid to the Fair Director listed on the P&L, which should be included as part of the County's expenditures. He said the Fair should be self-supporting.

Chairman Ayers agreed and expressed reservations about another full time position, which would draw a substantial amount of money from the unobligated general fund.

Supervisor Tucker remarked the time is critical to have a plan in place.

Vice-Chair Campbell said it would take a substantial amount of money to prepare the golf course for the Fair and then repairing the course after the Fair.

Mr. Rodgers said it would be a one-day effort to fill in the ruts and damage to the golf course. He mentioned that arrangements have been made to accommodate overflow parking.

Chairman Ayers stated he would not like to see the Fair go away, however, the County is now faced with an \$80,000 expense. For that reason, he could not support this request.

Supervisor Tucker remarked that the Fair is a wonderful community event and agreed there should be more emphasis on agricultural aspects.

A motion was presented by Supervisor Tucker that the Board appropriate \$80,000 from the unobligated General Fund to prepare for the 2020 County Fair.

A RESOLUTION, NO. 2019-0018-R

A resolution, declaring Amherst County a Second Amendment Sanctuary County

Approved as to form and legality by the County Attorney

BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST, VIRGINIA:

I. That the Board of Supervisors of Amherst County hereby declares Amherst County a Second Amendment Sanctuary County, as follows:

WHEREAS, the Second Amendment to the United States Constitution reads: "A well-regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed"; and

WHEREAS, Article I, § 13 of the Virginia Constitution reads: "A well-regulated militia, composed of the body of the people, trained to arms, is the proper, natural, and safe defense of a free state, therefore, the right of the people to keep and bear arms shall not be infringed"; and

WHEREAS, the Board is concerned that certain legislation prefiled for introduction in the 2020 Virginia General Assembly, and certain legislation that has been introduced in the United States Congress, may have the effect of infringing on the rights of law-abiding citizens to bear arms, as guaranteed by the United States and Virginia Constitutions; and

WHEREAS, the Board is concerned that passage of these bills, imposing unnecessary burdens on law-abiding citizens and inviting further regulations and burdens, and if to be enforced by local officials, will impose on the County unfunded mandates, whether as a formal mandate or as a practical requirement of enforcing the law; and

WHEREAS, the General Assembly has expressed its intent, in Section 15.2-915 of the Code of Virginia, 1950, as amended, that rules, regulations, and administrative actions "governing the purchase, possession, transfer, ownership, carrying, storage or transporting of firearms, ammunition, or components or combination thereof," other than workplace rules, is an exclusive preserve of State government, and that local law enforcement is the responsibility and



preserve of the Sheriff and the Commonwealth's Attorney, who are independently elected officers under the Virginia Constitution; and

WHEREAS, nevertheless, the Board wishes to express its sentiments, together with the sentiments of the Amherst County community as a whole, with regard to this important matter, and its continuing intent to take lawful action to protect these important rights.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF AMHERST COUNTY, VIRGINIA, that:

- 1. Amherst County is hereby declared a Second Amendment Sanctuary County, wherein the rights of law-abiding citizens to keep and bear arms for the purposes of lawful self-defense, community defense, and hunting, as protected by the United States and Virginia Constitutions, is part of the fabric of the community since before the foundation of the Republic, and is and must be respected and celebrated; and
- 2. Amherst County urges the General Assembly, the United States Congress, and other agencies of State and Federal government not to adopt, accept, or enact any provision, law, or regulation that may infringe, have the tendency to infringe, or place any additional burdens on the right of law-abiding citizens to bear arms; and
- 3. Amherst County expresses its intent to continue to take lawful actions to protect and support the rights of its citizens to keep and bear arms as guaranteed by the United States and Virginia Constitutions; and
- 4. Amherst County opposes, in particular, any provision, law, or regulation that may impose additional regulatory burdens on its citizens or result in mandates, whether mandatory or practical, to expend additional public funds on enforcement or administration of such laws, or to require the constitutional officers of the locality to do so; and
- 5. The County Administrator is directed to cause true copies of this resolution to be forwarded to the County's representatives in the General Assembly and the United States Congress, together with the Chairmen or Presidents of each chamber therein; and

II. This resolution shall be in force and effect upon adoption.





Potential Disadvantages



- No financial "backstop" in the event of a total loss of scheduled airline service
- Airport Fund has sufficient operating and capital reserves to operate in excess of structure (no Federal Aviation Regulation Part 139 air carrier operating one year or until conversion to a general aviation airport operating/financial requirements)
- Airport Fund has generated operating surplus every year since 2016. This is attributed to growing the airport's revenue base, managing expenses, minimizing the use of new debt while paying off existing debt
- Airport capital reserves and retained earnings are approximately \$1.2 million
- If necessary, a "safety net" could be incorporated into the Agreement A set amount of reserve can be maintained in the Airport Fund



LYH is a Significant Regional Economic Asset

- Economic impact of \$180 million in the City of Appomattox, Bedford, and Campbell Lynchburg and the Counties of Amherst,
- Supports 1,774 jobs
- Generates wages totaling \$61 million
- Generates state and local taxes of \$3.2 million

Mr. Chairman, Mrs. Tucker and Gentlemen

I was appointed to the board of the Amherst Economic Development Authority thirteen years ago, serving as Member, Chairman, extended time as Treasurer and as an at large Member. I can say it has been an interesting trip from the time when the EDA Board was given limited information. The first several years of the EDA, the County of Amherst had a Director of Economic Development who was responsible to the County Administrator not the Board of the EDA. We were not able to receive any financial information and the Development officers were instructed by the County Administration not to tell the EDA Board what work was being done by the officer. An example of the lack of communication is shown by the fact the Board was presented a rental contract for CVCC after the school had moved into its rental space. The Board had no part in the negotiations of the rental agreement but the contract was with the EDA and it sublet space to CVCC.

When Mr. Crosby was appointed as interim County Manager things started to turn around. We were given financial reports and found we had enough funds to hire an EDA Director. Under Mr. Warren Teats leadership, we engaged Mr. Lee Cobb to be a consultant and he, Mr. Cobb, gave the EDA a first class education on how a well run EDA functions. From that time on, the Authority made great progress.

The Authority developed and presented to the Board of Supervisors, strategic plans, proposed new "Branding" for the

County, assumed ownership of the Amelon Business Park where it owns and manages rental property, has completed environmental studies on a pad in the Amelon Business Park, leveled the land to the point that the pad is ready for sale and construction, conducted classes in Leadership Amherst, met with many County businesses and prospects, granted incentives when deserved, established working relationships with Commonwealth and regional development agencies and the Amherst County Board of Supervisors.

On November 24, I will reach the age of 88 and it is time for a younger person to fill my shoes so please accept this as my notice that I will not request reappointment when my term expires in January 2020. I appreciate the opportunity to serve Amherst County and if the Board wishes and directs, I will remain serving for a limited time until a replacement is sworn into office.
