**BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF AMHERST, VIRGINIA:**

**I. That the Amherst County Board of Supervisors ("Board") hereby supports the request from the Economic Development Authority of Amherst County to have Parcel ID 161-A-146 rezoned from P-1, Public Land, to M-1, Industrial District, for economic development, as follows:**

**RESOLUTION OF APPROVAL AND AUTHORIZATION**

**WHEREAS**, Amherst County, Virginia (hereinafter the "County"), is the owner in fee simple of that certain parcel of land designated as Parcel ID 161-A-146 (hereinafter the "Property"); and

**WHEREAS**, the Economic Development Authority of Amherst County (hereinafter the "EDA"), created pursuant to the Industrial Development and Revenue Bond Act (hereinafter the "Act"), as set forth in Section 15.2-4900 *et seq.* of the Code of Virginia (1950, as amended), has requested that the County consider rezoning said property from P-1, Public Land, to M-1, Industrial District, for economic development purposes as contemplated by the Act.


**NOW, THEREFORE, BE IT HEREBY RESOLVED** that the County does hereby support the rezoning of the Property from P-1, Public Land, to M-1, Industrial District, directs the County Attorney to draft the necessary documents to effectuate such a rezoning, and grants the Amherst County Board of Supervisors Chairman and/or County Administrator the authority to sign any all necessary documents to finalize such rezoning.

**II. That this resolution shall be in force and effect upon adoption.**
