10. Terms and Conditions:
- A. All landfill users will be billed for landfill services. The fees charged will be due and payable within thirty (30) days of the billing date of the statement to the landfill user. For all statements remaining unpaid thirty (30) days or more, a penalty in an amount established by the Amherst County Code, as amended, §13-5 shall be assessed thereon. Additionally, for all statements remaining unpaid at the end of sixty (60) days following the date of issue of the billing statement, there shall be assessed thereon interest at the rate established by ordinance, and the interest shall be collected upon the charges and any penalty assessed thereon.
 - B. There shall be imposed upon any person chargeable with delinquent accounts, fees to cover the administrative costs and reasonable attorney's or collection agency fees actually contracted for. The attorney's or collection agency's fees and the administrative costs shall be in addition to all penalties and interest, and shall be determined pursuant to the terms and amounts as set forth by the Code of Virginia, 1950 as amended, §58.1-3919 and the Amherst County Code, as amended, §14-9.
 - C. No further charges will be allowed on accounts against which penalties and late charges have been assessed until paid in full (that is, disposal will be by cash or approved check only). The undersigned agrees to pay all costs incurred in collecting past due balances and any finance and collection charges and expenses, including attorney's fees incurred by the Solid Waste Department in collection efforts.
 - D. Solid Waste Department also retains the right to reverse the Business Credit received by the Landfill customer if an account falls in the past due status.
 - E. All matters arising out of this Application shall be governed by laws of Commonwealth of Virginia and Courts of appropriate jurisdiction of Amherst County.
 - F. Amherst County Department of Solid Waste and Amherst County Landfill reserve the right to cancel any account that is, in their opinion, too frequently delinquent in making payments.
