### 3. SUBDIVISION PLAT

## A. Indiana Thurston and Joe Tyler Estate

Request submitted by Leslie Peters (Wingfield Real Estate) for approval of a preliminary plat for a four (4) lot subdivision located on Partridge Creek Road (State Route 670). The total project area is 26.698 acres. The parcel is zoned A-1 Agricultural Residential District and is further identified as tax map number 125-A-102.

Mr. Rowe presented to the Planning Commission the staff report and stated that staff recommends that the preliminary subdivision plat be approved.

Mr. Bryant explained that staff was researching other localities to better understand the process.
