## IX. Commonwealth's Undertaking Of A Preliminary Engineering Report (PER) Concerning Potential Long Term Utilities Service For The Lower Rapidan Campus Of Central Virginia Training Center (CVTC)

Mr. French provided the Board an article published in the <u>Amherst New Era-Progress</u> on November 24, 2016 regarding the transfer of individuals from CVTC. (See Attachment 1)

Mr. French advised that copies of Hurt & Proffitt's Preliminary Engineering Report (PER) of December 5, 2014 summarized CVTC's existing water & sewer utilities for ACSA and had been previously provided to Senator Steve Newman's staff, as well as the ACSA Board and the County's EDA Board.

Mr. French said he was contacted by a consulting engineer retained by the Commonwealth, requesting information about ACSA utilities in the CVTC area. Mr. French advised he provided information to the consulting engineer which was included in an earlier PER outlining water/wastewater utility concerns. Mr. French advised he had received confirmation the Commonwealth was examining alternatives for providing water/wastewater utility service to the Lower Rapidan Campus if retained.

Mr. French advised if a new PER report is produced, he will provide copies to the Board, County staff and EDA.

Supervisor Tucker said she was concerned with all of the moving parts of this issue and the need for coordination regarding a "good" impact for the County and asked who would be the gatekeeper for this.

Mr. Rodgers said that CVTC is in a manpower crisis and moving to schedule its closure in 2018-2019. He said that Senator Newman is focused on caring for the people and the lower Rapdian Campus but not on economic development as the County is.

Mr. Rodgers said Senator Newman sees a possibility of getting a portion of the campus declared excess immediately. Mr. Rodgers indicated it would be important to get those families to support this and help the state to get top dollar for this property so what is sold will go into a trust fund for those families.

# Newman: Va. at risk of lawsuit over CVTC

Transferring "fragile" individuals from Central Virginia Training Center could open the commonwealth up to a lawsuit if any of them is injured, state Sen. Steve Newman said last week.

Newman. R-Bedford County, and Del. Scott R-Lynchburg, Garrett, sent a letter to Secretary of Health and Human Resources William Hazel on Oct. 24 asking him to slow down part of the plan to close the Madison Heights facility housing people with severe intellectual and developmental disabilities.

In August, the Department of Behavioral Health and Developmental Services surprised guardians of residents at CVTC in announcing the department would reclassify beds, lowering the level of care at Building 31 by the end of the year because of a nursing shortage.

As a result, at least six residents and their guardians faced a choice of accepting a lower level of care, transferring across the state or moving into a group home, which many CVTC families consider inferior care. DBHDS plans to close Building 31 by the end of December 2017 as the plan progresses to shutter the facility in 2020 after an agreement with the Department of Justice.

"I'm fairly convinced that if we move forward with closure without having the hospital-type beds surrounding a number of these individuals that

we will be making a decision to increase mortality, and I believe that is morally wrong, and I just can't stand for that," Newman said. "If we end up moving some of these people out of that facility to a facility that is not capable of taking care of them, and there are negative outcomes, then I think that the commonwealth should be responsible for those outcomes."

The commonwealth has put itself in a position to forfeit sovereign immunity, which protects governments from civil lawsuits, Newman said. The individuals whose departure from CVTC was sped up recently are among "the most fragile," he said.

The Department of Behavioral Health and Developmental Services, which was handling the response letter for the secretariat, was still in the process of preparing it last Wednesday.

Newman talked with Hazel personally after sending the letter, he said. Newman expected DB-HDS to continue plans for CVTC as scheduled.

"They're going to derate that facility," Newman said.

Family members of people who reside at CVTC say the process has been rushed, that they have been bullied toward accepting lower quality care outside the training center and that they have a choice to stay, according to a list of concerns attached to the legislators' letter. The concerns mirror those family members have made since the closure was announced.
