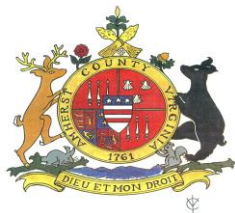

- 11 - Site Plans/Plats are required for re-submittals with corrections: 7 -Planning Commission, 3 -Planning Staff/Attorney , 1-VDOT.
- 1 - Extra subdivision plat will be needed for the School Board if for a residential subdivision.

ZONING PERMIT REQUIRING A MAJOR SITE PLAN:	\$200.00
ZONING PERMIT REQUIRING A MINOR SITE PLAN:	\$75.00
