VI. Monthly Financial Report

A. October & November 2017 Monthly Reports

ACSA Director Robert Hopkins presented the October and November 2017 Monthly Reports. Mr. Hopkins explained that because of a lack of development in certain areas and general reduction in water usage by Service Authority customers, water and wastewater sales, revenues, and sales volume for 2017 are down as compared to 2016. New development water and sewer connections are down 35.3% and 23.1%, respectively, from 2016.

VII. Discussion

A. 2017 Bad Debt Write-offs

Mr. Hopkins addressed the Board regarding the annual task to write off old bad debts. The total for 2017 is \$23,296.26, a slight increase from 2016, but still only 0.53% of the budget.

Mr. Hopkins advised that, by forwarding the bad debt list to the Virginia Set-Off Debt Program, the Service Authority may be able to recoup some of the money if those citizens are due a tax refund from the Commonwealth of Virginia.

He advised that the Service Authority has a program to pay off a debt over time and is very accommodating about working with customers. He would like to make some billing changes, including adding to the bill, after the payment date and late fee date, a date 2 weeks later after which the water will be cut off. He also plans to monitor the billing more closely himself and track delinquent customers.

Chair Tucker asked if the Service Authority could obtain a better address for those citizens from the Treasurer's office. Mr. Hopkins replied that most of the bad debt "unable to locate" listings are renters who skipped out on their bills and are now gone from the area or in the area at other, unknown locations.

Mr. Hopkins said some of those folks have financial setbacks, some are renters and some just skip out of paying their bill.

By motion of Supervisor Campbell and with the following vote, the Board approved the write-off of three-year old bad debts and directed staff to forward such debts to the Virginia Set-Off Debt Program.

B. DEQ Wastewater Treatment Plant Regulations Changes

Director Hopkins explained that the VA Dept. of Environmental Quality is looking at changing the regulations for waste water treatment plants to lower the level of ammonia nitrogen in plant discharges.

Mr. Hopkins described the Service Authority's two small treatment plants and estimated these changes would cost an estimated \$250,000 to \$500,000 in upgrades to each.

Mr. Hopkins has participated in a joint effort of Virginia utilities, including presenting at a DEQ public hearing and sending a letter, to request that DEQ put this action on hold to allow the Commonwealth's wastewater utilities to accumulate money to do this upgrade and allow the Commonwealth to establish a funding assistance program.

Mr. Hopkins recommended acceptance of this plan of action. He will keep the Board informed of events as they proceed. DEQ is supposed to finalizes its plans later in 2018.

C. ACSA Orientation and State of the Utility

Director Hopkins provided the Board with an orientation and State of the Utility to refresh the Board and benefit the newest Board member, Ms. Moore.

Mr. Hopkins directed Board members to the ACSA Water and Wastewater Facility Plan for general information on the Service Authority, and explained the organizational chart and their positions, a Strengths-Weaknesses-Opportunities-Threats analysis, various metrics that demonstrate the financial position of the Service Authority, 2017 accomplishments and upcoming projects.

Supervisor Pugh asked about the CDBG Block Grant and what is being done with that money. Mr. Hopkins noted that the Service Authority has received the \$500,000 grant from the State, for which \$250,000 is dedicated in ACSA reserves.

Mr. Hopkins advised the County CDBG money is being used on housing and drainage projects and the ACSA grant will be used to rehabilitate eighty-year-old sanitary sewers on Main Street, and also on several additional streets, depending on the construction bids.
