To adopt "ACSA Rate Schedule Effective 1/1/2019" to revise water and sewer charges and fees effective January 1, 2019, and request the Amherst County Board of Supervisors to amend §§15-122 and 15-123 of Article IV, Chapter 15, Water and Sewers, of the Amherst County Code to adopt such revised water and sewer charges and fees.

THE AMHERST COUNTY SERVICE AUTHORITY HEREBY RESOLVES:

1. Pursuant to its authority under Sections 15.2-5114, 15.2-5136, and 15.2-5137 of the Code of Virginia, 1950, as amended, the Board hereby adopts the attached "ACSA Rate Schedule Effective 1/1/2019" of rates, fees, and charges, which shall be in force and effect for all water bills issued on January 1, 2019, or thereafter.
2. The Board of Directors requests the Board of Supervisors to codify these provisions into the County Code, to go into effect for bills issued on or after January 1, 2019, until changed.

- Notes:
1. Consult the rate schedule for water connections on dual lane highway (U.S. Route 29).
 2. Any water connection 1" or larger, sewer connection larger than 4", or commercial or industrial connection should be referred to the Director.
 3. There are three (3) methods of determining availability fees other than the above chart:
 - (a) Estimating average daily water usage based on plumbing fixture counts and/or occupancy, dividing by 275 gallons per day to determine the number of Equivalent Residential Units, and multiplying by the residential availability fee.
 - (b) Using the documented average daily water usage of similar facilities.
 - (c) Estimate of daily water usage sealed by a licensed architect or engineer and provided on the estimator's letterhead to the Director.
- (a), (b), or (c) requires execution by the applicant of a written agreement with ACSA that, if actual average daily water usage exceeds the estimate, an additional availability fee will be assessed.
