Mr. Rodgers said the County made an effort to find other buyers by using the EDA and other avenues of marketing. The only offer received was from Mr. Tommy Lloyd who owns land around the school and has offered \$250,000 for the property.

Mr. Rodgers said the property was assessed in 2014 at \$3,047,100. It was necessary to have a professional appraisal of the school, which valued it at \$170,000.

Mr. Alan Wood of Madison Heights Virginia, addressed the Board and supported the proposed sale of this property to the Lloyd family. He also commented that if the Board approved the sale, he asked that the Board give some of those funds back to the schools.

Mr. Jeffrey Floyd of Amherst, Virginia, addressed the Board and said he was raised in that community and has known Mr. Lloyd for years as a farmer, business man and community leader. Mr. Floyd said he supported the proposed sale of the school property to Mr. Lloyd.

He also commented on the \$50,000 that is currently in the County's budget and asked the County Administrator bring back proposals to see if that would be feasible.

Mr. Rodgers advised he has approached bond counsel and that money would go back to the schools. He said he would bring this matter back to the Board.

B. Arcadia/Exxon Mobile Remediation Program

County Attorney Lockaby addressed the Board and explained this is to grant a uniform environmental covenant for the property that was a former fertilizer plant. Exxon Mobil was the successor to the fertilizer manufacturer and cleaned up the property. This work was certified by independent engineers and by the DEQ.

The County has agreed that this portion of the property will never be used as residential property. Exxon Mobil and the DEQ agreed that if any further problems occur, Exxon Mobil will be responsible to clean it up and DEQ has the right to inspect. This property is currently used as a trail

C. Special Exception Request #2018-297

Planning/Zoning Director Bryant addressed the Board and provided information regarding a special exception submitted by Edward Dillard, Jr. to allow breeding, raising and training of dogs. Mr. Dillard has operated under a state kennel license and he has an existing 10x10 outdoor kennel with no proposed changes. This property is 1325 Sugar Hill Tunnel Road, Amherst, Virginia.

- 1. Number of dogs: No more than 20 dogs shall be kenneled at the facility at any one time.

- 3. <u>Home Occupation</u>: Applicant shall abide by Section 905.02.3 of the home occupation ordinance, which states, "The home occupation shall not generate excessive traffic nor produce obnoxious odors, glare, noise, vibration, electrical disturbance, radio activity or other conditions detrimental to the character of the surrounding area."
