Providing that the Public Utilities Director is vested with the authority to sign contracts binding the Amherst County Service Authority, and that he may delegate that authority to others so long as he advises the Amherst County Service Authority Board of such delegation prior to its exercise.

BE IT RESOLVED BY THE AMHERST COUNTY SERVICE AUTHORITY BOARD:

I. That the Amherst County Service Authority Board hereby provides that the Public Utilities Director is vested with the authority to sign contracts and other

agreements binding the Amherst County Service Authority, and that he may delegate that authority to others so long as he advises the Amherst County Service Authority Board of that delegation prior to its exercise, as follows:

WHEREAS, by long-standing practice, the Public Utilities Director has executed contracts and other agreements binding the Amherst County Service Authority; and

WHEREAS, this practice is necessary for implementation of the powers granted to the Amherst County Service Authority under Virginia Code § 15.2-5114, including the power to enter into contracts providing for or relating to services and facilities of any system owned or operated by the Amherst County Service Authority; and

WHEREAS, the Amherst County Service Authority Board wishes to formalize the authority of the Public Utilities Director to sign contracts and other agreements binding the Amherst County Service Authority.

NOW, THEREFORE, BE IT RESOLVED BY THE AMHERST COUNTY SERVICE AUTHORITY BOARD:

That to effect the authority granted to the Amherst County Service Authority by Virginia Code § 15.2-5114, the Board hereby provides that the Public Utilities Director is vested with the authority to sign contracts and other agreements binding the Amherst County Service Authority, and that he may delegate that authority to others for such purposes as he deems appropriate and necessary so long as he advises the Amherst County Service Authority Board of any such delegation prior to its exercise.

II. That this resolution shall be in force and effect upon adoption.
