At a regular meeting of the Board of Supervisors of Amherst County and held at the Administration building thereof on Tuesday, the 4th day of November, 2014, at 1:00 p.m. at which the following members were present:

Chairman Kidd called the meeting to order. Supervisor Marks gave the invocation and led the Pledge of Allegiance.

IV. Citizen Comments

Chairman Kidd asked if anyone wished to speak to come forward.

Mr. Harvey Sellers of Amherst, Virginia, addressed the Board with several issues regarding broadband service on Rt. 60W, a contract with Verizon, and the former Amherst Baptist Church. Mr. Sellers stated he favored the leasing of the church to civic groups and asked the Board to give this idea consideration.

Chairman Kidd closed the citizen comment section of the meeting.

V. <u>Special Presentation</u>

A. Introduction of Alyssa Elliott, Associate Extension Agent, ANR, VCE Amherst Extension Office

Mr. Kevin Irvin, Senior Extension Agent introduced Ms. Alyssa Elliott as the new ANR Extension Agent with the Amherst Extension Office effective October 21, 2014. Ms. Elliott provided the Board with background information regarding her education and experience.

B. Region 2000 Partnership Annual Report

Ms. Megan Lucas, CEO, Region 2000 Alliance and provided the Board with an overview of her role with Region 2000 Alliance.

Mr. Ben Bowman of Region 2000's Workforce Investment Board advised the Board of coordination with workforce and education systems. Mr. Bowman mentioned a new website available (region2000works.org) to reach out to job seekers. Mr. Bowman asked if the Board had any ideas and space available to meet the people in the community in order to serve the folks in Amherst County.

Mr. Gary Christie, Executive Director of Region 2000 advised the Board of their support helping with grants, industrial parks, regional strategic plans for economic development, and regional tourism. Mr. Christie thanked the Board for allowing Region 2000 to work on trail projects, CDBG projects in Madison Heights, and the radio tower at High Peak that will add a fourth communication tower for the Amherst County system as part of the Tobacco Row System.

VI. Consent Agenda

A. Minutes - October 7, 2014 and October 21, 2014

Chairman Kidd asked the Board if there were any questions regarding the minutes. Supervisor Marks advised there were no questions on the minutes; however, Mr. Marks had a question regarding Item 8. Appropriations FY2014 Appropriation Request – Reconcile FY2014 Juvenile Confinement Care Cost. Mr. Marks referred to the August 5, 2014 Minutes and questioned why the "true-up" in the amount of \$90,305 for FY2013 took 15 months and the "true-up" in the amount of \$56,945 for FY2014 took only four months.

Mr. Rodgers acknowledged Supervisor Marks' question and advised he will have to track down why it took 15 months in FY 2013 versus 4 months in FY2014. Supervisor Marks questioned how this is handled in our budget and realized it would be hard to estimate how many juveniles will be in the program and the total costs. Mr. Rodgers advised the Board anything anticipated will be included in the budget. Mr. Rodgers advised that he can provide answers to

the Board during each meeting if Board members can provide their questions prior to the meeting.

VII. County Administrator

Mr. Rodgers spoke to the Board regarding several pending issues. Mr. Rodgers advised the Board he and Ellen Bowyer, the Amherst County Attorney met with the Sale family regarding the Buffalo River Reservoir property and advised the parties have reached a tentative agreement. Ms. Bowyer is drafting a lease that will reflect the orally agreed terms by all parties.

Mr. Rodgers provided information regarding the budget. The CIP budget inputs are due next week and the first meeting will held by the budget working group. J. D. Mitchell, the HR Consultant is moving forward with the review of the personnel policies and working on a draft document.

Supervisor Tucker asked Mr. Rodgers if the number of hours allotted for the HR Consultant is sufficient. Mr. Rodgers explained Mr. Mitchell is moving forward at a satisfactory pace and working with a large group to gather their input. The Board will be presented with a report for approval and Mr. Rodgers advised this process is going as fast as it should considering the limited number of hours the HR Consultant works.

VIII. New Business

A. Resolution 2014-0032-R Dissolving the Amherst County Towing Advisory Committee

Ellen Bowyer, Amherst County Attorney, provide the Board with information regarding Resolution 2014-0032-R. Ms. Bowyer informed the Board that the Amherst County Sheriff

advised the work has been completed by the Towing Advisory Committee and recommended the Board adopt Resolution 2014-0032-R to dissolve the Amherst County Towing Advisory Committee.

Ms. Bowyer further noted that Resolution 2014-0032-R lists all participants on the Amherst County Towing Advisory Committee and expresses the Board's appreciation of their participation.

A. AMERESCO Performance Contract

Chairman Kidd advised the Board that the AMERECO Performance Contract is for discussion only.

Mr. Rodgers asked if the Board had any questions.

Chairman Kidd discussed the Goodwin Street building and the cost of replacement of the HVAC system which is quoted at \$584,000.

Mr. David Proffitt provided the Board with past information that approximately five years ago a firm was hired to study the Goodwin Street Building to replace the HVAC system.

Supervisor Curd suggested to the Board to consider a workshop to define what to do with the space needs and what decisions need to be made.

Supervisor Marks advised the Board there are some things that absolutely need to be done and suggested that it establish priorities.

Supervisor Pugh suggested calling references such as Patrick and Shenandoah Counties and to plan a meeting with the School Board to discuss this. Mr. Pugh favored Social Services space needs as a number one propriety.

Supervisor Tucker remarked on the need to take care of what we currently have versus building a new space and Supervisor Tucker expressed she is fine with a second opinion on the Goodwin Building; however, to entertain building more space concerns her.

Mr. Rodgers advised that in 2012 the Board solicited energy efficiency contractors. The Board selected AMERESCO to use this energy saving contracting method and to also look at the School District's needs and our existing building needs to find energy savings to pay for the improvements that are long overdue. AMERESCO's references were checked before they were hired and AMERESCO made their role clear on all aspects of the projects. Mr. Rodgers advised the Board they can prioritize the projects in any order. Mr. Rodgers advised he can set up a work shop to discuss space needs and a joint workshop with the School Board regarding their portion of AMERESCO's proposals.

Supervisor Pugh suggested a meeting with the School Board to discuss these options and a second opinion on the HVAC system at the Goodwin street building.

Supervisor Tucker asked why the Board was questioning AMERESCO's study and why the Board hired these folks to do the study and then nothing is done.

Supervisor Pugh agreed that the Board should be agreeable to the energy savings and the need to make a decision on the Goodwin Building.

Supervisor Marks asked about the debt service to do this work. Mr. Rodgers advised the money will come from the money saved on school and administration projects. Mr. Rodgers stated this money will come from maintenance accounts and no additional amount of funding will be obtained, only moving money from one account to another.

Supervisor Curd advised that the Board should explore funding options.

Supervisor Pugh remarked that our debt is decreasing each year so there would be extra money.

Chairman Kidd asked the Board what direction the Board desired to with and what option would be the best.

It was the Board's consensus to set up a joint meeting with the School Board but it was not necessary to have AMERESCO at this meeting. Mr. Rodgers indicated he could have AMERESCO stand by on the phone or in another room if the Board desired.

Mr. Rodgers further advised the Board he will set up a workshop on the space needs study with Mr. Bill Gillespie, of MRG Consulting, and the Board on the Goodwin Building.
