Chairman Pugh called the meeting to order at 7:01 p.m. Supervisor Marks gave the Invocation and led the Pledge of Allegiance.

IV. Citizen Comments

Chairman Pugh asked the audience if anyone wished to come forward to speak.

Ms. Martha Bryant of Madison Heights, Virginia reported on General Assembly actions related to training centers and provided the Board with a copy of Senator Newman's bill SB1300 which prohibits closure of the three training centers and to remove these properties from the surplus land list. Ms. Bryant also provided a copy of language in the Governor's budget which would change bonds. Ms. Bryant explained bonds as being a government-related investment for the long term to pay for renovations such as roofs, waterlines, boilers and intra-structure for state facilities. This language redirects to localities and also to private sponsors, which she sees as a move towards privatization of these facilities.

Ms. Bryant advised the Board that Senator Tom Garret is a co-patron of Senator Newman's bill and she hoped the Board would consider writing a letter of support of appreciation of his efforts.

Chairman Pugh thanked Ms. Bryant for her comments.

Chairman Pugh closed the Citizen Comments section.

V. Public Hearings

A. Designation of Route 60 as Scenic Byway

Dean Rodgers, County Administrator, informed the Board the Virginia Department of Transportation is prepared to designate Route 60 as a Scenic Byway. On April 2, 2013, the Board adopted Resolution 2013-0008-R supporting this designation.

Mr. Don Austin, Residency Administrator for the Virginia Department of Transportation, addressed the Board regarding the effects of this designation. Mr. Austin stated the existing signage including billboards are grandfathered in; however, if existing signage is replaced it would then fall under the Byway regulations and would not be allowed. Mr. Austin advised this would not apply to church signs. Mr. Austin explained if a sign structure is replaced or falls down, it would no longer be grandfathered; however this does not apply to advertisement changes on existing signs.

Chairman Pugh opened the Public Hearing and asked for anyone in favor of or opposed to the scenic byway designation to come forward.

B. Design-Build Contract Procedures

Ellen Bowyer, Amherst County Attorney provided the Board information regarding Resolution 2015-0001-R, which gives the Board more flexibility in procurement of major construction projects. Ms. Bowyer distributed to the Board changes on pages 4 & 6. These changes reflected additional recommendations made by Supervisor Marks on January 9, 2015. Ms. Bowyer stated the Board must adopt the Design-Build Contract Procedures by ordinance or resolution to be consistent with State Law.

Chairman Pugh stated he found the document in good working order with these changes.

On motion by Supervisor Kidd, and with the following vote the Board adopted Resolution 2015-0001-R with noted amendments to pages 4 and 6 providing for the adoption of the DesignBuild Contract Procedures to be used as an alternative to the procedures governing the traditional competitive sealed bid process for procuring development of construction projects.

VIII. County Administrator Report

A. CIP work session

Mr. Rodgers informed the Board corrections are being made at this time to the CIP Plan Score Sheet and will be supplied later in the meeting. Chairman Pugh stated the Board will move to Item B. and return to Item A. once the corrected score sheet is available.

B. Supplemental Budget materials

Mr. Rodgers provided information to the Board regarding the supplemental budget materials and explained the Supplemental Budget Score sheet includes the funding requests from all County departments, agencies and nonprofits that are not included in the Capital Improvement Plan. The staff working group has prioritized all the requests based on their urgency to ongoing county operations.

Mr. Rodgers asked the Board to rank all the projects from 1 to 54 in importance and to disregard costs and funding which will be addressed at a later time. A combined score/ranking will be presented at the next budget workshop.

Mr. Rodgers stated that if the Board has questions to go directly to the individual departments for answers. Staff members have been instructed to forward to Mr. Rodgers any questions received from Board members in order that those questions can be shared with all Supervisors. Mr. Rodgers asked the Board to prioritize each budget request with a rank of 1 to 54 and return the score sheet to staff by January 29, 2015.

Mr. Rodgers answered Supervisor Tucker's question regarding the dumpster on 60 west near Burleys Hollow road and advised he has spoken with two people and is actively searching for another site.

The Board returned to Item A. CIP work session of the Agenda.

Mr. Rodgers explained to the Board the FY16 Capital Improvement Plan Score Sheet and scores totaled on far right of the sheet. He explained the lower the points the higher the priority placed in order of importance and asked if the Board was in agreement with these priorities. Mr. Rodgers stated the Board should not to be concerned about funding and cost at this time.

The Board discussed the placement of certain items on the FY16 Capital Improvement Plan Score Sheet and the outcome of this discussion has been reflected by the following Board votes. On motion by Supervisor Marks, and with the following vote, the Board voted to adopt changes to the FY16 Capital Improvement Plan Score Sheet moving existing item priority Number 12 Admin. Bldg. HVAC Replacement up and that it fall under item priority Number 6.
