A. Second Stage | Amherst - "Cultivate Amherst" Creative Community Summit

Ms. Suny Monk of Second Stage | Amherst addressed the Board and thanked Mr. Rodgers and Supervisor Tucker for participating in Cultivate Amherst to draw people to Amherst County.

Ms. Monk stated that an opportunity came to our local government in the name of a local government challenge grant from the Virginia Commission of the Arts (VCA). This grant requires budgeting dollars up to \$5,000 that will be administered by the VCA to support local art activities in the County. Ms. Monk stated this money will not go to Second Stage | Amherst.

Ms. Monk advised the Amherst Town Council has appropriated \$1,250 toward this challenge grant and she asked the Board to appropriate \$1,250 for next year. As one condition of the grant, the VCA must see this amount in the County's budget.

By motion of Supervisor Ayers and with the following vote, the Board approved an appropriation of \$1,250 from the Unobligated General Fund for the purpose of obtaining a matching grant from the Virginia Commission for the Arts which will fund a Creative Community Summit conference for Amherst County.

B. Discussion - Volunteer Status of Rescue Squads

Gary Roakes, Director of Public Safety, Jeff Tanner, Captain of the Amherst Life Savings Crew and Vickie Padgett, Captain of the Monelison Rescue Squad addressed the Board regarding volunteer status of rescue squads in the County.

Chairman Marks thanked all and asked them to help the Board understand what is happening and why.

Captain Padgett explained the changes that have occurred over the past years and said a majority of younger individuals are now giving up volunteer work and making this a full-time, professional career. It has become harder to have people available to run extra calls. Also, the state now has added more requirements and people do not have the commitment as in the past to fulfill all the requirements.

Mr. Roakes explained there is always a place for volunteers but there is a need to have more career staff.

Captain Tanner explained volunteer numbers are dwindling and this is not isolated to Amherst County but is an issue other states are facing.

Captain Padgett said if volunteers are on duty, they must be at the station. If they are not on duty, they are not required to have on their radios on to answer calls.

Supervisor Ayers asked both Captains Tanner and Padgett if they saw the situation improving in the future. Both Captains responded they did not see the situation improving based on past history.

Mr. Roakes advised that part time wage rates have not increased in 13 years and now Amherst County, which is one of the lowest paid in the area, has to compete with other localities to get the manpower it needs to fill its gaps in manning.

Supervisor Tucker expressed her appreciation for their time and patience in working with the Board.

Chairman Marks thanked Mr. Roakes, Mr. Tanner and Ms. Padgett for explaining what the County is facing.
