Wholesalers	\$.05 per \$100 Gross Receipts
Gasoline & Fuel Retailers	\$.08 per \$100 Gross Receipts
Retailers (Including Auto Dealers)	\$.20 per \$100 Gross Receipts

ADDITIONAL RATES AND FEES	
For Gross Receipts Under \$50,000	\$10.00
Public Utility Companies	Multiply .005 times total gross receipts
Itinerant Merchants, Auto Graveyards, and Others	\$200.00 - 30 days or \$500.00 annually
Peddlers	\$50.00 annually
Door-to-Door	\$20.00 annually for each individual
