Complaints of unnecessary force or other serious misconduct will be investigated by a Professional Standards Investigator. This investigation will be independent of the deputy's command.

Complaints of less serious misconduct, i.e.; rudeness, discourtesy, minor infractions of the rules, are often best handled by discussing your concerns with a supervisor. If you wish to discuss your concerns with a supervisor, you may call 434.946.9300.
